Staff provided a report on all utility budgets and capital improvement programs to the Board of Supervisors on January 3, 2008, a portion of which explained the need for a rate increase for the storm water budget.

Fiscal Impact: Additional revenue to Storm Water account.

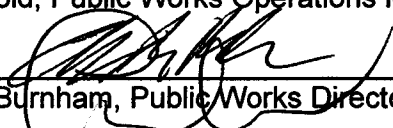

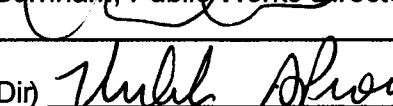

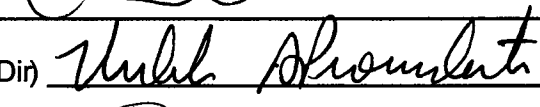

AN ORDINANCE AMENDING TITLE 12, WATER, SEWERAGE AND DRAINAGE, CHAPTER 12.17, STORM WATER SERVICE CHARGES, SECTION 12.17.040, SERVICE CHARGE RATES, BY INCREASING THE SERVICE CHARGE RATES BY 5% ON BILLS DATED ON OR AFTER JULY 1, 2008; AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OR SUPERVISORS OF CARSON CITY DO ORDAIN:

SECTION I:

That Section 12.12.040 of the Carson City Municipal Code is hereby amended as follows:

12.17.040 Service charge rates. There is hereby levied upon all developed real property within the boundaries of the city the following service charges which shall be collected from the owners of such properties:

Classification	Monthly Rate
"Single Family Property"	[\$2.92] <u>\$3.07</u>
"Multi-Family Property"	[\$18.67] <u>\$19.60</u>
"Public Property"	[\$20.47] <u>\$21.49</u>
"Manufacturing Property"	[\$24.57] <u>\$25.80</u>
"Commercial Property"	[\$26.42] <u>\$27.74</u>
