D-1. ADM-07-155 ACTION TO CONSIDER AN ADMINISTRATIVE PERMIT REVIEW APPLICATION FROM ELIZABETH L. RUDNICK, STRATEGIC REAL ESTATE SERVICES, (PROPERTY OWNER: BANK OF AMERICA CORPORATION) TO ALLOW FOR THE CO-LOCATION OF WIRELESS ROOFTOP-MOUNTED ANTENNAS, ON AN EXISTING BUILDING ON PROPERTY ZONED RETAIL COMMERCIAL (RC), LOCATED AT 600 EAST WILLIAM STREET, APN 002-145-01 (1-012) - Ms. Eskew-Herrmann introduced this item and reviewed the staff report. She noted staff's recommendation of approval based on seven findings and eleven conditions. She reviewed the public noticing process and, in response to a question, Ms. Green advised of having received no response either in favor of or in opposition to the application.

Mr. Yee acknowledged having reviewed the staff report and his agreement with the conditions of approval. Ms. Eskew-Herrmann responded to questions regarding the ten-day appeal period and the Notice of Decision. In response to a question, Ms. Green advised that a building permit is on file.

Ms. Eskew-Herrmann called for additional questions or comments and, when none were forthcoming, approved ADM-07-155, an administrative permit application from Elizabeth L. Rudnick of Strategic Real Estate Services, property owner Bank of America Corporation, to allow for the wireless co-location of three panel antennas, each 45.3 inches by 6 inches by 3 inches; one equipment cabinet, 54 inches by 30 inches by 30 inches; and three microwave antennas, 25 inches, on an existing building on property zoned retail commercial, located at 600 East William Street, APN 002-145-01, based on seven findings and subject to the conditions of approval contained in the staff report, with the understanding that any acknowledgments to the Hearing Examiner by the applicant may be considered as further stipulations or conditions of approval to the application.
