Staff Summary: CCMC 4.13.150 provides for the imposition of a \$100 fine upon the holder of a liquor license for the first time a person is issued a criminal citation related to the sale of liquor at a licensed premises. Pursuant to NRS 178.484, The Defendant must sign this document before being released from jail. By signing below, the Defendant promises to appear at all times and places as ordered by the Court releasing him or her and as ordered by any Court before which the charge is subsequently heard, (b) will comply with the other conditions which have been imposed by the Court and are stated in the document, (c) and, if he or she fails to appear when so ordered and is taken into custody outside of this State, the Defendant waives of his or her rights relating to extradition proceedings. This document serves as a receipt of bail posted which shall be used to satisfy fine or cost imposed by the Court. Any law enforcement officer who has probable cause to believe the Defendant has violated any condition of his/her release is ordered to arrest him or her.

Pursuant to NRS 199.335, If you fail to appear at the time and place required by the order of the court, and fail to surrender yourself within 30 days after the date on which you were required to appear and the charge you failed to appear for was a felony, you are guilty of a CATEGORY D FELONY FAILURE TO APPEAR. If the charge you failed to appear for was a gross misdemeanor (and no felonies), you are guilty of a GROSS MISDEMEANOR FAILURE TO APPEAR. If the charge you failed to appear for was a misdemeanor (and no felonies or gross misdemeanors), you are guilty of a MISDEMEANOR FAILURE TO APPEAR. If you leave the State of Nevada with the intent to prosecute and the charge you failed to appear for was a felony, gross misdemeanor or misdemeanor, you are guilty of a CATEGORY FELONY FAILURE TO APPEAR.
