WE, THE UNDERSIGNED, HEREBY DEDICATE IN FEE TO CARSON CITY, A CONSOLIDATED MUNICIPALITY OF THE STATE OF NEVADA, for public purposes, lands owned by us or in which we have vested interest, particularly described as follows, to wit:

A portion of Parcel No. 3 as shown on the Parcel map for John R. McManus, filed in the Official Records of Carson City, Nevada, in Book 5, Page 1312, on the 3rd day of October 1986, as File Number 50233, and more fully described by metes and bounds as follows, to wit:
