Subject Title: Action to adopt Resolution No. _____, a resolution approving and authorizing the Mayor to sign a 2010 Addendum to Interlocal Contract #2008-4 addressing funding from Carson Water Subconservancy District to Carson City for the Carson River Park Phase 2 Project.

Staff Summary: Parks and Recreation Department staff has requested a two-year time extension from the Carson Water Subconservancy District on a non-point source pollution enhancement grant for the Carson River Park Phase 2 Project. This Interlocal Contract addendum will change only the grant's termination date to June 30, 2012, and not the original grant award amount of \$7,500.

Recommended Board Action: I move to adopt Resolution No. _____, a resolution approving and authorizing the Mayor to sign a 2010 Addendum to Interlocal Contract #2008-4 addressing funding from Carson Water Subconservancy District to Carson City for the Carson River Park Phase 2 Project.

Explanation for Recommended Board Action: The original grant award from the Carson Water Subconservancy District was \$7,500 and was intended to provide a number of enhancements to reduce non-point source pollution at Carson River Park. The project site is located near Lloyd's Bridge on Carson River Road and adjacent to Silver Saddle Ranch. If the Board of Supervisors approves this addendum to the Interlocal Contract, it will allow City staff to begin implementation of the site improvements designed by Hansen Landscape Architects and Wood Rodgers, Inc., in fiscal years 2010/2011 and 2011/2012.

A RESOLUTION APPROVING AND ADOPTING A 2010 ADDENDUM TO
INTERLOCAL CONTRACT #2008-4 ADDRESSING FUNDING FROM CARSON
WATER SUBCONSERVANCY DISTRICT TO CARSON CITY FOR CARSON
RIVER PARK PHASE 2 PROJECT

WHEREAS, any two or more political subdivisions of the State of Nevada may enter into cooperative agreements for the performance of any governmental function pursuant to NRS 277.045; and

WHEREAS, NRS 277.045 provides that every such agreement must be by formal resolution or ordinance of the governing body of each political subdivision included and must be spread at large upon the minutes, or attached in full thereto as an exhibit, of each governing body; and

WHEREAS, the parties to the agreement agree to amend Interlocal Contract # 2008-4 to extend the grant's termination date to June 30, 2012, for the Carson River Park Phase 2 Project entered into between Carson City, Nevada and the Carson Water Subconservancy District's with the desire to adopt and approve the said agreement as required by NRS 277.045. A copy of the agreement is attached to this Resolution as Exhibit "A;" and

WHEREAS, all parties to the agreement agree to amend Interlocal Contract # 2008-4 to extend the grant's termination date to June 30, 2012, for the Carson River Park Phase 2 Project entered into between Carson City, Nevada and Carson Water Subconservancy District, are political subdivisions of the State of Nevada.

NOW, THEREFORE, BE IT RESOLVED that the terms and conditions of the agreement for the Carson River Park Phase 2 Project entered into between Carson City, Nevada and Carson Water Subconservancy District are hereby adopted and approved; and

BE IT FURTHER RESOLVED that the agreement for the Carson River Park Phase 2 Project entered into between Carson City, Nevada and Carson Water Subconservancy District shall be spread at large upon the minutes or attached in full thereto as an exhibit, and that a copy of this Resolution shall be sent to Carson Water Subconservancy District.

**2010 ADDENDUM TO INTERLOCAL CONTRACT #2008-4
ADDRESSING FUNDING FROM
CARSON WATER SUBCONSERVANCY DISTRICT TO
CARSON CITY FOR CARSON RIVER PARK PHASE 2 PROJECT**

WHEREAS, on July 17, 2008, the CARSON WATER SUBCONSERVANCY DISTRICT (hereinafter referred to "CWSD") and CARSON CITY (hereinafter referred to as "CARSON CITY") entered into an Interlocal Contract (hereinafter "Interlocal Contract #2008-4") addressing funding from CWSD to CARSON CITY for Carson River Park Phase 2 Project ("the Project"); and

WHEREAS, on August 6, 2009, CWSD and CARSON CITY authorized an Addendum to Interlocal Contract #2008-4 extending it to June 30, 2010; and

WHEREAS, it has been determined that Interlocal Contract #2008-4 needs to be extended for an additional two years; through fiscal year 2011-12, with a carryover of funds from fiscal year 2009-10 of \$7,500.00.

NOW, THEREFORE IT IS AGREED:

1. Interlocal Contract #2008-4 shall be extended two years and shall terminate June 30, 2012, with a carryover of \$7,500.00 for use in fiscal years 2010-11 and 2011-12.
