**Staff Summary:** The District Attorney's Office was awarded funding in early October, 2010, to hire an additional Victim/Witness Coordinator. Receipt of this grant will fund that Victim/Witness Coordinator position for 2011.

**Recommended Board Action:** I move to approve the submittal of an application for the State of Nevada Attorney General's Office STOP Violence Against Women Grant in the amount of \$40,000 for the employment upon receipt, a Victim/Witness Coordinator in the District Attorney's Office.

**Explanation for Recommended Board Action:** The District Attorney's Office presently has one Victim/Witness Coordinator. One position is not adequate to serve the community need. The grant funds, if approved, will fund an additional position for 2011. We will apply for additional grant funds to sustain the position.

## APPLICATION DUE DATE FOR 2010 STOP VIOLENCE AGAINST WOMEN GRANT PROGRAM

**Carson City, NV** – Nevada has been allocated funds under the 2010 STOP Violence Against Women Grant program for qualified programs that meet specific federal and state objectives.

The purpose of the STOP Violence Against Women Program is to encourage the development and implementation of more effective law enforcement, court, and prosecution strategies to combat crimes of sexual assault, domestic violence, dating violence, and stalking. It also encourages development and enhancement of victim services in cases involving those crimes.

“The STOP Program envisions partnerships among law enforcement, prosecution, courts and victim services organizations to enhance victim safety and hold offenders accountable for their crimes,” said Attorney General Catherine Cortez Masto.

A letter of intent to apply for this funding is due at the Attorney General’s Office by **October 8, 2010**. The deadline for the application is Friday, **October 28, 2010 by 5:00 PM**.
