Subject Title: Action to enter into insurance agreements with Affiliated FM for property insurance at a total premium of \$ 267,192, Travelers Insurance Company for auto physical damage and excess liability coverage at a total premium of \$338,509, Great American for government crime insurance at a total premium of \$9,745, and with Illinois Union for Landfill Pollution Legal Liability insurance at a total premium of 11,921 for a grand total of \$627,367 for FY 11-12.

Staff Summary: Staff is recommending that Carson City continue their insurance relationships with the above carriers for FY 11-12. The total premiums for FY 10-11 were \$639,892 so the total decrease in premium cost would be 1.96 %.

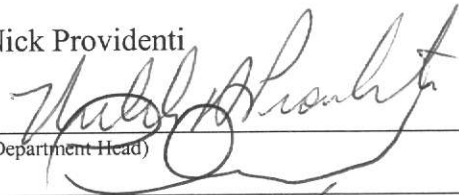

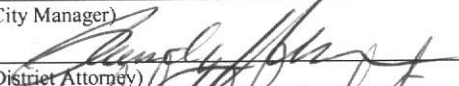
