Subject Title: Action to approve the renaming of a section of US Highway 50 between North Saliman Road and the Carson City Freeway from US Highway 50 to East William Street.

Staff Summary: The section of road between North Saliman Road and the Freeway interchange is no longer designated as US Highway 50. The East William Street name needs to be extended to the Freeway interchange, and all of the addresses along that stretch of road will have to be changed.

Recommended Board Action: I move to approve the renaming of a section of US Highway 50 between North Saliman Road and the Carson City Freeway from US Highway 50 to East William Street.

Explanation for Recommended Board Action: The Carson City Freeway Bypass has altered the route of US Highway 50. The Highway now goes South along the Freeway until it reaches Fariview Dr. As a result, the section of Highway 50 that falls between North Saliman Road and the Freeway can no longer be called US Highway 50. This section of road will become E. William Street and all of the addresses along this corridor will have to be changed. City staff will notify all appropriate authorities as well as all affected property owners.
