Subject Title: For Possible Action: To adopt a resolution approving and authorizing the mayor to sign a Cooperative Agreement for Transfer of Operational and Fiscal Control of NRS 473 Fire District from the Nevada Division of Forestry to Carson City (*Stacey Giomi*).

Staff Summary: The Division of Forestry operates a separate and distinct fire district serving the wildland fire needs of the western most portion of Carson City. This district resides wholly within the political jurisdiction of Carson City. This agreement will transfer operational and fiscal control of the district to Carson City to allow the Fire Department to assume the duties of that district and the wildland fire program.

Recommended Board Action: To adopt a resolution approving and authorizing the mayor to sign a Cooperative Agreement for Transfer of Operational and Fiscal Control of NRS 473 Fire District from the Nevada Division of Forestry to Carson City.

Explanation for Recommended Board Action: By signing this document Carson City will assume control of the wildland fire program. This assumption of duties will allow the wildland firefighters to be used throughout the City, not just in those west side areas where the district currently exists. With the increased land acquired during the lands bill, a wildland seasonal firefighting program is necessary to improve fire protection to all portions of the community. In addition, the district was originally established to maintain forest fire protection and with the increased presence of homes and privately owned property in the district, the original need has changed.

Applicable Statute, Code, Policy, Rule or Regulation: NRS 277.

Fiscal Impact: Revenue increase of approximately \$240,000 for FY 12 and \$340,000 for FY 13.

Explanation of Impact: The revenue will come from C-tax and ad valorem sources presently going to the district. Out of those revenue funds, the city will operate the wildland program and make payments (as indicated in this agreement) to the Division of Forestry through the end of FY 13. Note: these funds are presently collected; this is not an increase taxes or fees, simply redistribution.


Funding Source: Consolidated Tax and ad valorem presently being collected.

**COOPERATIVE AGREEMENT FOR TRANSFER
OF OPERATIONAL AND FISCAL CONTROL OF
NRS 473 FIRE DISTRICT**

I. IDENTIFICATION OF ENTITIES

- A. CARSON CITY, is a political subdivision of the State of Nevada (hereinafter "CITY");
- B. The CARSON CITY FIRE DEPARTMENT, the City fire department organized pursuant to the terms of the Carson City Charter for the purpose of fire protection in the City (herein after "DEPARTMENT");
- C. The State of Nevada Department of Conservation and Natural Resources (hereinafter "DCNR") which exists pursuant NRS 232.010(1), and the Nevada Division of Forestry (hereinafter "DIVISION") which exists pursuant to NRS 232.090(c), are both agencies of the State of Nevada (and are from time to time collectively referred to as "STATE" in this Agreement);
- D. The SIERRA FOREST FIRE PROTECTION DISTRICT (hereinafter "DISTRICT"), is a fire district organized pursuant NRS Chapter 473, which is currently administered by the Division.

II. RECITALS

WHEREAS, all signatories to this Agreement are public agencies authorized by Chapter 277 of the Nevada Revised Statutes to enter into interlocal and cooperative agreements with each other for the performance of governmental functions; and

WHEREAS, CITY and DIVISION have jointly operated, managed and funded that portion of the DISTRICT which is wholly located within Carson City; and

WHEREAS, it is the intention of CITY on future date to dissolve that portion of the DISTRICT wholly located within Carson City, and that in preparation for the future dissolution of the DISTRICT, all functions described below be transferred from DIVISION to CITY and DEPARTMENT, which will be fully assumed by these entities upon the future dissolution of the DISTRICT.

WHEREAS, CITY and STATE desire to transfer day to day operations, wildland firefighting response, emergency response, management and maintenance of both real and personal property at Fire Station 11, firefighting training, and fiscal control of the DISTRICT'S finances and budget to the DEPARTMENT;

NOW THEREFORE, it is agreed between the parties as follows:

III. TERMS

A. Effective Date

This Agreement shall be effective April 1, 2012.

B. Termination

This Agreement shall automatically terminate upon the dissolution of the DISTRICT by CITY. In the event CITY does not dissolve the DISTRICT, the Agreement may terminate upon the written mutual assent of both parties.

C. Assignment, Transfer and Acceptance of Rights, Duties, Responsibilities

1. DIVISION agrees to assign and transfer all rights, duties, responsibilities and liabilities for the operation, management and fiscal control of the DISTRICT, except as may be noted in this Agreement. CITY and DEPARTMENT consent to the transfer, and agree to accept operational and fiscal control of the DISTRICT including the transfer and use of certain personal property, including but not limited to fire apparatus, vehicles, other mobile equipment, and other specifically owned property as detailed in the Inventory attached hereto as Exhibit A.

2. All rights, duties, responsibilities and liabilities for operational, fiscal and budgetary control of the DISTRICT, as expressed in chapter 473 of the Nevada Revised Statutes and in the action taken by the Carson City Board of Supervisors upon dissolution of the DISTRICT, shall rest with the Carson City Board of Supervisors and delegated to the DEPARTMENT.

3. On the effective date of this Agreement, responsibility for the provision of wildland fire suppression services within the DISTRICT will transfer to CITY and DEPARTMENT.

D. Personnel

On June 30, 2013, all full-time State employees currently funded by DISTRICT will cease to be funded by DISTRICT. Those employees shall be reassigned or laid off in accordance with State policy and no terminal payoffs will be charged to DISTRICT.

E. Fiscal

1. Fire Emergency Funding

CITY and DEPARTMENT shall maintain appropriate contingencies, reserves and fund balances for the purpose of ensuring adequate funding for the cost of emergency fire suppression, particularly wildland fire suppression.

2. Transfer of Fund Balance, After-acquired Revenue and Outstanding Claims

a. Upon future approval by the Legislative Interim Finance Committee, DIVISION shall transfer any unexpended budget monies from Fiscal Year 2012 to CITY.

b. Any fire reimbursement, grant or other revenue realized from services provided by DISTRICT prior to the effective date of the Agreement which has not been received by that date shall be forwarded by DIVISION to DEPARTMENT within fourteen business days of receipt by DIVISION.

c. Any outstanding claims against DISTRICT incurred for goods and services provided to DISTRICT prior to June 30, 2012, for which billing was not received before the transfer, shall be forwarded by DIVISION to DEPARTMENT for payment within fourteen business days of receipt by DIVISION.

3. Revenue Neutrality for the 2012/2013 Biennium

a. The parties recognize that this Agreements calls for the transfer of fire services in the middle of the State of Nevada's Biennium; therefore, DISTRICT agrees to keep DIVISION budget revenue neutral for the 2012/2013 Biennium. DIVISION and DISTRICT agree that the following total amounts are required to maintain DIVISION's budget neutrality. DISTRICT agrees to remit to DIVISION quarterly payments which comprise the following total amounts:

b. Should either the Fire Captain (PCN 0162) or Battalion Chief (PCN 0067) positions listed in Paragraph E(3)(b) above be vacant at any time during the 2012/2013 Biennium, the position(s) will be kept vacant and the savings that result from the vacancy(ies) shall accrue to the benefit of DISTRICT and reduce the amount of the payment to DIVISION.

F. Liability

1. Indemnification

Until DISTRICT is dissolved, and to the extent allowed by law, DISTRICT agrees to indemnify and defend the State of Nevada, DEPARTMENT, DIVISION and their officers and employees from any and all claims, suits and judgments that may arise after the effective date of this Agreement that are based on DISTRICT'S performance thereunder or from the subsequent operation of DISTRICT.

2. Workers' Compensation Claims and Insurance

On the effective date of this Agreement, DISTRICT shall be responsible for the payment of workers' compensation insurance coverage and benefits for any DISTRICT employee. The STATE will retain all liability of worker compensation claims made by any of the affected employees hereunder through June 30, 2013.

G. Real and Personal Property

1. Occupation and Use of Fire Stations

CITY and DEPARTMENT will reassume full responsibility for the use and occupancy of Fire Station 11 located at 2222 W. College Parkway in Carson City.

2. Inventory

It shall be the duty of DIVISION to identify its furnishings, appliances, or fixtures at Fire Station 11, specifying the disposition of each item, and to provide the DEPARTMENT with a copy of this list prior to the effective date of this Agreement.

DIVISION and DEPARTMENT shall conduct a joint inventory of DISTRICT prior to the effective date of this Agreement. Prior to conducting this inventory, the DIVISION agrees to provide DEPARTMENT with any information pertaining to the condition and maintenance of the station that DEPARTMENT may require. The facility and equipment inventory are included with this agreement.

3. Schedule of Equipment and Mobile Equipment

a. DIVISION and DEPARTMENT shall mutually complete a schedule of the District's equipment and mobile equipment in the possession of the DIVISION no later than the effective date of this Agreement. It is the responsibility of both parties to inventory and appropriately identify any and all equipment and mobile equipment jointly in order to differentiate it from the property of the DIVISION. DIVISION and DEPARTMENT shall review and accept in writing the completed schedule of equipment and mobile equipment contained in the Inventory attached hereto as Exhibit A.

b. Possession, ownership and title of the equipment and mobile equipment purchased with DISTRICT taxpayer funds will be transferred to the DEPARTMENT on the effective date of this Agreement, unless the parties mutually agree to an alternative ownership in writing. Ownership and title of the equipment and mobile equipment purchased by DIVISION from State funds will be retained by DIVISION unless the parties mutually agree to an alternative ownership in writing. The disposition of any equipment and mobile equipment mutually funded by DIVISION and DISTRICT shall be fairly and reasonably distributed between DIVISION and DEPARTMENT.

4. Maintenance

On the effective date of this Agreement, assuming that possession, ownership and title of the equipment and mobile equipment have transferred pursuant to Paragraph G(3) above, DEPARTMENT shall assume all responsibility for the cost of maintenance, repairs and replacement of its equipment and mobile equipment.

5. Access to Dispatch Records

DIVISION shall provide DEPARTMENT access to dispatch records maintained by FireRMS once they are final and have become public records

H. Entire Agreement

This Agreement contains all the commitments and agreements of the parties, and oral or written commitments not contained herein shall have no force or effect to alter any term or condition of this Agreement, unless modified in accordance with Paragraph (I) below.

I. Amendment

This Agreement may be amended or modified only by the mutual written agreement of the parties which has been ratified in accordance with law.

J. Severability

In case any one or more of the terms, sentences, paragraphs or provisions contained herein shall for any reason be held to be invalid, illegal, or non-enforceable, in any respect, such invalidity, illegality, or non-enforceability shall not affect any other terms, sentences, paragraphs, or provisions and this Agreement shall be construed as if such invalid, illegal, or non-enforceable provision had never been contained herein.

K. Breach, Cure and Waiver

1. Failure of either party to perform any obligation of this Contract shall be deemed a breach. Except as otherwise provided for by law or this Contract, the rights and remedies of the parties shall not be exclusive and are in addition to any other rights and remedies provided by law or equity, including but not limited to actual damages, and to a prevailing party reasonable attorneys' fees and costs.

2. Termination upon a declared default or breach may be exercised only after service of formal written notice, and the subsequent failure of the defaulting party within fifteen (15) calendar days of receipt of that notice to provide evidence, satisfactory to the aggrieved party, showing that the declared default or breach has been corrected.

3. A waiver of any breach of any provision of this Agreement by any party shall not be construed to be a waiver of any preceding or succeeding breach.

L. Governing Law; Venue

This Agreement shall be governed, interpreted and construed in accordance with the laws of the State of Nevada and venue for any action based upon its terms and the parties' performance thereunder shall be in the First Judicial District Court of Carson City.


