Mayor Teixeira called the meeting to order at 7:55 a.m. by welcoming all in attendance. (Roll call was not taken, however, a quorum was present although Supervisors Smith and Tatro were absent.)

Senator Bryan also welcomed those in attendance, expressed his pleasure at being able to have a meeting here, and explained the status of several Congressional Bills on the currency transaction report, secondary commercial lending program, airport service legislation, fair credit report, health care, crime bill, illegal immigration impacts, and domestic abuse. Discussion ensued on public access television--Senate Bill 2195, specifically, referencing SB 1822, banking procedures/consolidations and their negative impacts on availability of Nevada's commercial capital, prison lawsuits and the potential use of federal mediators to resolve these issues, crime and medical programs, television and radio regulations, efforts to reduce the federal deficit, his support for a balanced budget, his election platform, the federal employee reduction program and use of these funds to fight crime, and potential federal funding for the City's new public safety complex.

Mayor Teixeira announced the townhall meeting with Senator Bryan would commence at 9 a.m. in the Community Center Sierra Room. He thanked Senator Bryan for his time and adjourned the meeting at 8:30 a.m.

No formal action was required or taken. A tape recording of these proceedings is on file in the Clerk-Recorder's office. This tape is available for review and inspection during normal business hours.
