A. CALL TO ORDER, DETERMINATION OF A QUORUM, AND PLEDGE OF ALLEGIANCE (5:01:28) - Chairperson Vance called the meeting to order at 5:01 p.m. Roll was called; a quorum was present. Commissioner Kimbrough was absent. At Chairperson Vance's request, Commissioner Steele led the pledge of allegiance.

PROPERTY ZONED PUBLIC REGIONAL (PR), LOCATED AT 1870 RUSSELL WAY, APN 002-101-87 (5:05:57) - Chairperson Vance introduced this item. Mr. Plemel introduced Parks and Recreation Department Director Roger Moellendorf and Park Planner Vern Krahn, provided background information on the subject item, and reviewed the agenda materials. Mr. Krahn commended Mr. Plemel's presentation, and provided additional background information on the multi-use athletic center ("MAC") design. Mr. Krahn presented the MAC design in conjunction with displayed slides, and responded to corresponding questions of clarification at various points throughout the presentation. Mr. Krahn and Mr. Sharp responded to additional questions regarding funding sources, the project time table, future additions, and the construction management at-risk process.

Chairperson Vance entertained additional commissioner comments and, when none were forthcoming, thanked Mr. Krahn for his presentation. Chairperson Vance entertained public comments; however, none were forthcoming.

G-2. SUP-10-104 DISCUSSION ONLY REGARDING A PREVIOUSLY-APPROVED SPECIAL USE PERMIT, INCLUDING AN UPDATE FROM THE BREWERY ARTS CENTER (PROPERTY OWNER: BREWERY ARTS CENTER / CARSON CITY), ON THE STATUS OF PLANS TO CONSTRUCT AN OUTDOOR EVENTS PLAZA, ON PROPERTY ZONED PUBLIC REGIONAL ("PR"), LOCATED AT 449 WEST KING STREET, APNs 003-206-01, -02, AND 003-207-04 (5:40:08) - Chairperson Vance introduced this item. Mr. Plemel introduced Architect John Copoulos, and explained that Brewery Arts Center Executive Director John Shelton was unable to attend the meeting. Mr. Plemel noted that late material had been distributed to the commissioners. He provided background information on this item, reviewed the agenda materials, and responded to questions of clarification.

Chairperson Vance entertained public comment. (5:46:15) Architect John Copoulos discussed Brewery Arts Center fund raising activities. Commissioner Wendell expressed an interest in the Brewery Arts Center providing a project time line to the Planning Division, and Mr. Plemel offered to request a report from Mr. Shelton which could be provided to the commission at the March meeting. Mr. Copoulos responded to additional questions regarding project details. Chairperson Vance called again for public comment; however, none was forthcoming.
