

REQUEST: Discussion only regarding Ash Canyon Road maintenance work and improvements.

GENERAL DISCUSSION: Attached for your use find the pre-application form submitted to the Nevada Division of Environmental Protection, Bureau of Water Quality Planning, for the purpose of initiating a conversation about the potential 319(h) Grant to be used next year towards Ash Canyon Road. Staff has received communication from the Bureau of Water Quality Planning informing us that our project is eligible. Subsequent to the eligibility notice, staff had the opportunity to discuss how to make our application more competitive. This nomination constitutes the second phase of the project presently in progress calling for a written management plan and best management practices on Ash Canyon Road. We have constructed two small parking areas and increased the width of the road and turn-offs continue to eliminate the outside berm in order to facilitate drainage after rainfall events. The next grant would propose to work on additional improvements necessary to alleviate erosion and make the road safer for all users, plus some educational components.

RECOMMENDED ACTION: No action can be taken. This item is for discussion only.

319(h) PRE-APPLICATION, ASH CANYON EDUCATION AND SEDIMENT CONTROL

The Nevada Division of Environmental Protection's Bureau of Water Quality Planning (BWQP) has reviewed the above mentioned 319(h) Proposal Pre-Application, and based solely on the information contained in the Pre-Application, the Bureau has made the determination that the proposed project is eligible to compete to receive grant funding. Please note that the 319(h) program will only be able to fund outreach and education that is specifically targeted toward nonpoint source pollution education and prevention.

Based on this pre-approval, you are eligible to submit a complete proposal to the BWQP pursuant to the current solicitation found at http://ndep.nv.gov/bwqp/npsp_grant-2013.htm. Proposals will be accepted until 5:00 pm September 6, 2013 and will be ranked and chosen through a competitive process. 

Project Summary (150 word limit): Ash Canyon is an important perennial drinking water source for Carson City. It is also an area heavily utilized by hikers, mountain bikers, motorcyclists, OHVs, and street vehicles. In addition, the soils are extremely droughty and highly erodible.

Project Objectives: Reduce erosion in the Ash Canyon Road corridor and thus sediment in Ash Canyon Creek. Improve public awareness that their actions in the watershed impact their drinking water.

Project Overview: 1) The City will prepare and install public education signage in the Ash Canyon Road corridor. The education signage will remind the public about the surrounding natural beauty as well as their location and staying off dirt roads when they are wet, staying on existing roadways, controlling speed, and similar.

2) The City will install approximately 200 feet of rock armor within eroding roadside ditch. The city will install approximately 200 feet of rock to hold the toe of an eroding roadside cut slope.

Project Methods: 1) The City will design and install sturdy, durable signage along the road corridor. A 2012 grant to the City has allowed funding for mile markers and one sign at the bottom of the roadway. These signs would replace signs developed by the boy scouts which were not made of durable materials. 2) the City will install the ditch and slope stabilization.

Hi Lynn,

First, I would clearly describe how your new project tasks are distinct from those that are being accomplished via your existing Ash Canyon grant. Eliminate any confusion....Don't let anyone on the TAC think "Are we double-dipping here?" Specifically state that this is a next step/future phase project that is building on your existing efforts. Is it fair to say that your BMPs would be prioritized pursuant to your BMP Plan that is being funded by your existing grant? If yes say so. By showing how this effort builds on your first, this proposal's ranking will be stronger versus one that stands alone.

Second, I would make the BMP elements primary, and the Outreach/Signage element secondary. Purchase more rock (and plants?) and fewer signs. EPA is directing us to fund more projects that result in load reductions (of Sediment, N and P specifically). If your project budget leans on the BMP Implementation side, it's ranking will improve. As you did last year, provide load reduction estimates (for sediment).

Third, if your proposed BMP's look like a road maintenance project, this boat is gonna sink. 319(h)\$ are not supposed to supplant Public Works roadway O&M costs. Key word here....road IMPROVEMENTS, not maintenance. Actually, I would not even mention "road improvements." I would say DRAINAGE IMPROVEMENTS. Yes, if we control erosion, the road will stay put, but, emphasize how this project will mitigate the impact of erosion on WQ caused by unmanaged drainage versus a road that is unraveling. I know this is a fine line here, but simply put, a road maintenance project will rank at the bottom of the proposal pool.

- The Plan will include addressing Task 3 of our contract Attachment A: NDEP approved signage for public outreach and education regarding the importance of:
 1. Staying off dirt roads when they are wet (seasonal road closures)
 2. Staying on existing roadways
 3. Controlling speed on the steep downhill areas
 4. High clearance vehicles only
 5. Mile markers
- Eliminate roadway water from 3 large gullies
- Reinforce a minimum of 10 water-bars
- Delineate parking for 2 landing areas
- Install at least 1 informational public awareness sign
- Install 5 mile markers
