**Staff Summary:** This is a request to remove an existing arched window on the west side of the house and replace it with a rectangular window, as well as add three new windows to the rear of the house on the east side to provide additional view and light for a rear bedroom. Both the new and replacement window locations are not visible from the adjacent street.
