3. MEETING ITEMS

A. For Possible Action: REGARDING THE ABSENCE OF ANY COUNCIL MEMBER FROM THIS MEETING. (5:31:46) – Chairperson Horvath announced the resignation of Member Carole Brewer.

B. For Possible Action: TO RECOMMEND FOR APPROVAL BY THE BOARD OF SUPERVISORS THE CARSON CITY DOWNTOWN 20/20 GROUP'S PLAN OR VISION FOR IMPROVEMENTS FOR DOWNTOWN CARSON CITY. (5:59:30) – Chairperson Horvath noted that this discussion is for the landscaping portion of the plans. Doreen Mack introduced herself and presented the revitalization plan for the Carson City downtown, as part of the Downtown 20/20 Group's plans. Chairperson Horvath offered the Council's resources to help the group define a landscaping plan, based on the Council's standards.

There were no public comments and no action was taken.

C. For Possible Action: TO RECOMMEND TO THE BORD OF SUPERVISORS A “TREE CARE ASSIST INITIATIVE” PROGRAM. (6:18:34) – Member Peermann presented the agenda materials which are incorporated into the record. Vice Chairperson Shirk suggested combining tree care with neighborhood cleanup efforts. Mr. Moellendorf cautioned against additional costs and noted the City's bio-waste program twice per year and Chairperson Horvath considered helping with the program by promoting it on social media. Mr. Moellendorf suggested incorporating the promotion in the Arbor Day Celebration materials.

(6:35:02) – Public Comments: Ms. Mack suggested utilizing CarsonNow online publication and social media for promotion.

(6:43:14) – Mr. Moellendorf offered to work with the Department of Public Works on a survey and a press release with suggested dates for eco-waste collection, and to incorporate it in the Arbor Day Celebration. He also suggested working on a more comprehensive program for 2015.

D. Discussion Only: REGARDING WHETHER THERE IS A NEED TO RECOMMEND A CITY-WIDE TREE WATERING POLICY DURING DROUGHT EVENTS. (5:22:19) – Discussion ensued regarding the value of trees versus lawns. Healthy trees were regarded as part of a healthy ecosystem. Member Ozawa suggested educating the public on effective watering techniques such as time of day, mulching, and deep watering.

(5:36:34) – **PUBLIC COMMENTS:** Tom Henderson, President and Founder of Healthy Trees, explained the benefits of mulching. Mr. Moellendorf briefed the Council on the elaborate and computerized city irrigation system, which is based on the soil moisture.

(5:48:10) – Member Peermann suggested inviting “somebody from the City” to a future meeting, to get more information prior to a recommendation to the Board of Supervisors. Member Ozawa suggested inviting “someone from the water company”. Chairperson Horvath suggested making a list of drought-tolerant trees.

(5:54:35) – Mr. Peters suggested looking into the Truckee Meadows Water Authority information on water conservation. He also noted that large trees were most likely receiving water from other sources as their roots would spread wide.

E. For Possible Action: TO APPROVE PLANS FOR THE 2014 Arbor Day Ceremony and activities. (6:46:58) – Chairperson Horvath wished to increase community involvement. The Council had approved having the ceremony on Saturday, April 26, 2014 via a motion in the December meeting. Vice Chairperson Shirk mentioned that the poster contest had been cancelled by the Arbor Day organizers. She also proposed a 5K run/walk and suggested a meeting in March to formalize all the decisions. Discussion ensued regarding the location for the celebration. Mr. Moellendorf reminded the Council that candidates and a winner must be selected for the George Washington Ferris award during the March special meeting. It was proposed to have the celebration at the Vietnam Veteran's Memorial at Mills Park, and around 10 a.m.
