Subject Title: For Possible Action: To provide direction to staff regarding including a part-time BRIC front desk position in the General Fund or Redevelopment Fund in the preparation of the FY 2014-15 City budget. (Lee Plemel)

Summary: The tentative FY 2014-15 Carson City budget was approved on April 24, 2014, including the funding of the part-time BRIC front desk position from the General Fund in the amount of \$14,603. During ensuing discussion regarding the Redevelopment Fund budget, it was suggested that the position could be funded from the Redevelopment Fund rather than the General Fund. The Board then suggested that the RACC (Redevelopment Authority Citizens Committee) make a recommendation on whether or not the funding for the position should come from the Redevelopment Fund.

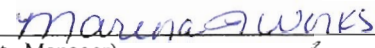

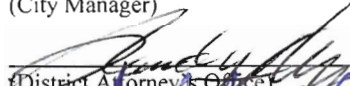

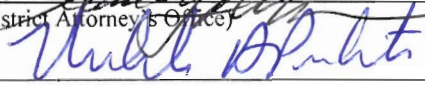

Subject: Recommendation to the Redevelopment Authority regarding the funding source for the part-time BRIC front desk position.

Recommended Motion: I move to recommend that the Redevelopment Authority fund the part-time BRIC front desk position for Fiscal Year 2014-15 from the General Fund or Redevelopment Fund [choose one].

Discussion:

The proposed FY 2014-15 Carson City budget for was presented to the Board of Supervisors and Redevelopment Authority on April 24, 2014. The tentative budget was approved including the funding of the part-time BRIC front desk position from the General Fund in the amount of \$14,603. During ensuing discussion regarding the Redevelopment Fund budget, it was suggested that the position could be funded from the Redevelopment Fund rather than the General Fund. The Board then suggested that the RACC make a recommendation on whether or not the funding for the position should come from the Redevelopment Fund. The Board is tentatively scheduled to adopt the final FY 2014-15 budget on May 19.

The part-time BRIC front desk position is necessary to have staff coverage throughout the day, five days a week, so the public can use the downstairs resources at the BRIC. Other Community Development staff covers the remainder of the time each day at the front desk. BRIC Resources include public computers as well as business training materials and conference rooms used by the public.

The budget for the position is \$14,603. The Redevelopment Fund has the available funds to cover this cost for FY 2014-15. Should the Redevelopment Authority/Board of Supervisors choose to fund the position from the Redevelopment fund, the "Undesignated Infrastructure Projects" account would be reduced in the budget by \$14,603, from \$271,942 to \$257,339.

In approving funding for this position, the Board of Supervisors has determined that the BRIC will continue to provide the services and will function as it has for last two-plus years for at least the next year, during which time the Board of Supervisors will consider the long-term objectives and functions for the BRIC during their annual strategic planning sessions once the new City Manager is hired.
