(5:36:18) – CK Baily stated that through a partnership between the Lion's Club and the Carson City Parks and Recreation Department, four picnic benches would be purchased to be used for the Kids' Fishing Day event and the Nevada Sesquicentennial Fair.

(5:38:40) – Member Powell updated the Board on the Sherriff's Office policy regarding 911 calls pertaining to Wildlife, which was to respond to threats to humans. Fred Voltz stated that he had heard otherwise. Member Powell suggested escalating the issue to the Sherriff's Office.
