## 5. AGENDA ITEMS

### 5.1 FOR POSSIBLE ACTION: TO PROVIDE RECOMMENDATIONS TO THE REDEVELOPMENT AUTHORITY REGARDING LONG-TERM POLICIES FOR THE USE OF UNDESIGNATED INFRASTRUCTURE FUNDS AND OTHER UNCOMMITTED REDEVELOPMENT FUNDS.

(5:32:22) – Mr. Plemel presented the Staff Report which is incorporated into the record. He also projected a list of potential redevelopment projects and suggested RACC members discuss each objective and rank the projects, in order to reach an average ranking and a consensus.

Below are the project rankings by RACC members, with one being the highest rank and 10, the lowest.

(5:51:29) – Vice Chairperson Hannaman inquired about the Community Development Block Grant (CDBG) and was informed that the grant funded improvements in low-to-moderate income neighborhoods and would not overlap with Redevelopment Areas. Member Lepire noted that any Third Street Plaza improvements had to include sidewalk improvements downtown. Mr. Plemel clarified that sidewalk improvements would go beyond the one-eighth cent tax funded downtown area.

**(5:54:14) – MOTION: I move to accept the potential objectives for the Redevelopment [Authority Citizens] Committee as outlined herewith: Number one being Third Street Plaza, two being sidewalk improvements, three being street lighting, four being Fuji Park, etc.**

**5.2 FOR POSSIBLE ACTION: TO PROVIDE DIRECTION TO STAFF REGARDING THE PREPARATION OF THE 2014 CHRISTMAS ORNAMENT.**

(5:54:56) – Chairperson Bagwell introduced the agenda item, gave background, and presented a proposed list of Christmas ornament designs from which to make a selection.

(5:55:51) – Vice Chairperson Hannaman explained that the McKeen Motor Car was suggested because it was the only restored car of its type in the United States, and was located in Carson City.

(5:56:11) – Member Lepire inquired about Carson City buildings “with direct ties that would match well with the [State’s] 150<sup>th</sup> Anniversary”. Discussion ensued regarding several homes in the Historic District that might qualify.

(6:00:01) – Chairperson Bagwell shared a suggestion received from a citizen who had attended the Carson City Central School (circa 1906), and proposed it for the ornament design. Member Wickstead suggested creating a web page for it. In response to a question, Chairperson Bagwell noted that the current building on 400 West King Street is not the schoolhouse, as the latter had been destroyed in a fire.

(6:02:25) – Discussion ensued and Vice Chairperson Hannaman explained that a rendering of Roberts House already existed. She also suggested the Nevada State Prison as another option.

**(6:13:18) – MOTION: I move to have Staff use 400 West King [Street] [Carson City Central School] as the building for the Christmas ornament for 2014. And additionally, on the Christmas ornament, to have a historical description of the building to be included with the ornament as well.**

(6:03:50) – Member Bonkowski clarified that the description would accompany the ornament, and will not be on it.

**6. NON-ACTION ITEMS:****a. STAFF REPORTS AND UPDATE ON MATTERS RELATING TO THE RACC.**

(6:04:21) – Mr. Plemel announced that concepts were being created for the downtown improvement, with a likely presentation to the Board of Supervisors in November, to receive a decision on a general design concept for Carson Street. He also noted that a workshop would be held on September 16, 2014; however, the time and date would not be available until September 5, 2013 at which time the public could call the Planning Department or City Hall to receive the information. Mr. Plemel also noted that a notice would be published in the Nevada Appeal and the item would be agendized for the next RACC meeting.

**b. RACC MEMBER REPORTS AND COMMENTS.**

(6:06:32) – Member Bonkowski announced that Tesla had chosen Nevada as their site for their battery plant. He also noted that a press conference was scheduled for 4 p.m. on Thursday, September 4, 2016 with Governor Sandoval, Mayor Crowell, and other dignitaries.

(6:07:22) – Vice Chairperson Hannaman stated that the Chamber of Commerce had partially funded the NV 150 Fair which was very successful. She did not know whether the Board of Supervisors would fund a future fair, calling it a great gift to area residents.

(6:08:06) – Member Lepire added that Tesla would bring 6,500 additional jobs to the area with an average salary of \$70,000 per year, making it the largest employer in the State.

**c. FUTURE AGENDA ITEMS.**

(6:09:25) – Report on the Board of Supervisors discussion on Redevelopment, sidewalk improvements, a tour of the State properties that could potentially be available to be utilized by Redevelopment.
