A RESOLUTION ESTABLISHING A CONTROLLED PARKING ZONE ON MUSSER STREET BETWEEN CARSON STREET AND DIVISION STREET WHICH WILL LIMIT PARKING TO TWO HOURS BETWEEN THE HOURS OF 8:00 AM AND 6:00 PM, MONDAY THROUGH FRIDAY, EXCEPT HOLIDAYS.

WHEREAS, Carson City Municipal Code provides that the Board of Supervisors may define and establish controlled parking zones within which the parking of vehicles is controlled and regulated with the aid of time limit signs, and;

WHEREAS, business owners in the area have requested that Musser Street, between Carson Street and Division Street be made available for patrons of their businesses, and;

WHEREAS, a limit in time for parking in that area of two hours during business hours will accommodate this request.

NOW, THEREFORE, BE IT RESOLVED THAT there is hereby established a controlled parking zone on Musser Street between Division Street and Carson Street which will limit parking to two hours between the hours of 8:00 am and 6:00 pm, Monday through Friday, except holidays.
