**1 - 4. CALL TO ORDER, ROLL CALL, INVOCATION, AND PLEDGE OF ALLEGIANCE** (8:28:39) - Mayor Crowell called the meeting to order at 8:28 a.m. Ms. Merriwether called the roll; a quorum was present. Salvation Army Lieutenant Mark Cyr provided the invocation. At Mayor Crowell's request, Sheriff's Office Business Manager Kathie Heath led the pledge of allegiance.

She commended Sheriff Ken Furlong on his auctioneer abilities. Mayor Crowell entertained additional public comment; however, none was forthcoming.
