A special meeting of the Carson City Board of Supervisors was held on Tuesday, June 30, 1992, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 12 noon.

NOTE: Unless otherwise indicated, each item was introduced by staff's reading/outlining/clarifying the Board Action Request and/or supporting documentation. Staff members present for each Department are listed under that Department's heading. A tape recording of these proceedings is on file in the Clerk-Recorder's office. This tape is available for review and inspection during the normal business hours.

Mayor Teixeira called the meeting to order at 12:10 p.m. Roll call was taken. A quorum was present although Supervisor Tatro had not yet arrived and Supervisor Bennett was absent.

ACTION ON A RESOLUTION BY THE CARSON CITY BOARD OF SUPERVISORS TO LEVY THE TAX RATE AS CERTIFIED BY THE NEVADA STATE TAX COMMISSION (1-0013) - Mayor Teixeira outlined the purpose of the session. (During his introduction, Supervisor Tatro arrived--12:12 p.m. A quorum was present as previously noted.) Ms. Walker reviewed the taxing entities, their rates, and the Board's action reducing the City's ad valorem rate. She distributed and discussed with the Board a comparison of the City's 91-92 and 92-93 rates as well as a comparison of other Nevada Cities' rates and services. (A copy was given to the Clerk.) Public comments were solicited but none made. **Supervisor Tatro moved that the board adopt Resolution No. 1992-R-45, A RESOLUTION TO LEVY THE FISCAL YEAR 92-93 TAX RATE AS CERTIFIED BY THE NEVADA STATE TAX COMMISSION.** **Supervisor Fettic seconded the motion.** Discussion included the indigent tax rate, the indigent tax rate for last year, justification for this year's increase, and Washoe Medical Center's indigent collection policies. Monies not spent this year will be carried over next year and next year's rate would be adjusted appropriately. Concern was expressed about the City being forced to support federally/state mandated programs. May Ruth French was advised that the City's liability for Washoe Medical services was limited to the City's ability to pay as indicated by the ten cent cap. Carson City is only responsible for its indigent residents. Joe Trinastic stressed his feeling that the Capitol City had needs beyond those of other cities and should not be compared with them. He also indicated that Carson-Tahoe should not have to compete with Washoe County's hospitals. He urged the Board to retain the current tax rates. Ms. Walker then explained procedures for billing other Counties for their indigent medical cases. Additional public comments were solicited but none made. The motion to adopt Resolution 1992-R-45 was voted by roll call with the following result: Ayes - Smith, Fettic, Tatro, and Mayor Teixeira. Nays - None. Motion carried 4-0.

Supervisor Smith moved to adjourn. Supervisor Fettic seconded the motion. Motion carried 4-0. Mayor Teixeira adjourned the meeting at 12:32 p.m.
