A special meeting of the Carson City Board of Supervisors was held on Monday, July 20, 1992, at the Community Center Sierra Room, 851 East Williams Street, Carson City, Nevada, beginning at 12:15 p.m.

Mayor Teixeira called the meeting to order at 3:18 p.m. Roll call was taken and a quorum was present although Supervisors Smith and Fetic were absent.

ACTION ON A RESOLUTION ASKING THE ADVICE OF THE REGISTERED CARSON CITY VOTERS WHETHER THE CARSON CITY CHARTER SHOULD BE AMENDED TO PROVIDE FOR THE ELECTION OF SUPERVISORS FROM THEIR WARDS IN THE PRIMARY ELECTION AND TO BE ELECTED AT LARGE IN THE GENERAL ELECTION AND OTHER MATTERS PROPERLY RELATED THERETO (1-0006) - Charter Review Committee Chairperson Don Carlson felt the Resolution reflected the Committee's intent. Comments were solicited but none made. Supervisor Bennett moved that the Board adopt Resolution No. 1995-R-53, **A RESOLUTION ASKING THE ADVICE OF THE REGISTERED CARSON CITY VOTERS WHETHER THE CARSON CITY CHARTER SHOULD BE AMENDED TO PROVIDE FOR THE NOMINATION OF SUPERVISORS FROM THEIR WARDS IN THE PRIMARY ELECTION AND TO BE ELECTED AT LARGE IN THE GENERAL ELECTION.** Supervisor Tatro seconded the motion and noted that the Resolution would allow the public to make the ultimate decision. Mr. Lipparelli explained that the Resolution would allow the Supervisors to be nominated rather than elected from their respective Wards. Supervisor Tatro expressed his intent to work against the proposal. Discussion indicated the results were not binding. The motion to adopt Resolution No. 1992-R-53 was voted by roll call with the following results: Bennett - Yes; Tatro - Yes; and Mayor Teixeira - Yes. Motion carried 3-0. Mayor Teixeira noted for the record that the copy would be delivered to Mr. Nishikawa's office immediately which would be within the legal parameters mandated for election items.

Supervisor Tatro then moved to adjourn. Supervisor Bennett seconded the motion. Motion carried 3-0. Mayor Teixeira adjourned the meeting at 12:20 p.m.
