D. MODIFICATION OF AGENDA

(5:31:44) – None. Ms. Pansky introduced Ms. Fralick and Ms. Yowell. She also noted that Joe Ward, Deputy District Attorney assigned to this Commission, had resigned to pursue other interests with the State and that Ms. Yowell would be replacing him. Vice Chairperson Drews introduced new Commissioner Karyn de Dufour, representing the State Historic Preservation Office (SHPO).

(5:33:07) – Vice Chairperson Drews explained that he was working on a contract basis with the Public Works Department regarding agenda item F-2 and therefore, he would abstain from voting. F. PUBLIC HEARING MATTERS

F-1 HRC-15-157 FOR POSSIBLE ACTION: TO APPROVE A REQUEST FROM PROPERTY OWNER JIM WARREN TO INSTALL FRONT YARD DECORATIVE FENCING, BEADBOARD PANELING ON THE FRONT PORCH CEILING AND TO PLACE A STONE CARRIAGE STEP ON PROPERTY ZONED SINGLE FAMILY 6000 (SF6), LOCATED AT 603 WEST ROBINSON STREET, APN 003-243-02.

(5:33:36) – Vice Chairperson Drews introduced the item.

(5:34:04) – Ms. Pansky gave background and presented the agenda materials with the accompanying photographs via a PowerPoint presentation, all of which are incorporated into the record. She also recommended approval of the project.

(5:37:20) – Jim Warren introduced himself and gave further detail on the renovations he was doing at 603 West Robinson. The commissioners commended Mr. Warren on the progress made to date. Commissioner Hayes suggested having a 36 inch fence.

(5:42:50) – MOTION: I move to approve HRC-15-157 a request from property owner Jim Warren to install front yard decorative fencing, 36 inches in height, beadboard paneling on the front porch ceiling, and to place a stone carriage step on property zoned Single Family 6000 (SF6), located at 603 West Robinson Street, APN 003-243-02 based on the findings and the conditions of approval outlined in the Staff Report, the Standards and guidelines for Rehabilitation, Carson City Historic District Guidelines and consistent with Historic Resources Commission Policies.

F-2 HRC-15-160 FOR POSSIBLE ACTION: TO CONSIDER A REQUEST FROM THE CARSON CITY PUBLIC WORKS DEPARTMENT FOR HISTORIC RESOURCES COMMISSION APPROVAL OF THE CARSON CITY DOWNTOWN STREETSCAPE PROJECT AS REQUIRED FOR FEDERALLY-FUNDED PROJECTS UNDER SECTION 106 OF THE NATIONAL HISTORIC PRESERVATION ACT OF 1966.

(5:43:58) – Vice Chairperson Drews recused himself as he was working with the City on this project. Commissioner Darney introduced the item and chaired this section of the meeting.

(5:44:15) – Ms. Pansky presented the agenda materials and accompanying photographs, incorporated into the record.

(5:47:43) – Danny Rotter, Public Works Engineering Manager, introduced himself and gave a brief overview of the project. Commissioner de Dufour was informed that the trenches would be dug near the utility lines and comprised eight-inch water lines “with 12 inches on either side”. Mr. Rotter added that they had been working on having the project completed by Nevada Day in 2016.

(5:55:00) – Ms. Pansky presented the Staff Report, incorporated into the item. Commissioner Hayes agreed with Ms. Pansky’s recommendation; however, he wished to explore other sources of funding for the blue line maps. Commissioner Drews suggested working closely with Prison Industries or obtaining private donations. Discussion ensued regarding Preservation Commission trainings and whether to submit one or two projects for a grant. Commissioner de Dufour stated that she would abstain from voting as she managed the [grant] program.
