**E-1. POSSIBLE ACTION TO RECOMMEND TO THE BOARD OF SUPERVISORS
ACCEPTANCE OF THE 90% DESIGN OF THE DOWNTOWN CARSON STREET
PROJECT; THE REGIONAL TRANSPORTATION COMMISSION AND THE
REDEVELOPMENT AUTHORITY CITIZENS COMMITTEE WILL MAKE SEPARATE
MOTIONS AND TAKE SEPARATE ACTION ON THIS ITEM** (4:32:08) - Chairperson Bonkowski introduced this item. Mr. Rotter introduced Project Manager Mike Bennett, of Lumos & Associates, and reviewed the agenda materials in conjunction with displayed slides. Mr. Rotter and Mr. Bennett responded to questions of clarification, and discussion ensued, throughout the presentation.

Chairperson Bonkowski entertained public comment. (5:39:52) Gil Yanuck discussed concerns regarding an “economic payback to the people that are putting all the money up for this, the taxpayers.”

(5:45:56) Jed Block discussed various businesses and events which draw people to the downtown area, and commended the project.

(5:49:52) Elinor Bugli, representing the Mile High Jazz Band Association, advised of monthly concerts in the downtown area. She suggested a wider stage “to accommodate bigger bands.” She expressed support for a permanent stage.

Chairperson Bonkowski entertained additional public comment and, when none was forthcoming, additional commissioner / committee member comments. RACC Chair Hannaman suggested Supervisor Karen Abowd “or myself ... to help you with some of the accessorization of the downtown.” RACC Vice Chair Lepire discussed changes to the downtown which the project has engendered. Mr. Rotter and Mr. Plemel responded to additional questions regarding downtown development standards. RACC Member Bagwell suggested updating the downtown development standards as soon as possible. RACC Member Wickstead expressed enthusiasm and the opinion “it's the right time for us and ... the horse rather than the cart.” RACC Member Mullet expressed support for requiring “some consistency” for such things as benches and waste cans in the downtown area. He commended Janet Kelly on redeveloping her building. RTC Chairperson Bonkowski commended staff on “an excellent job throughout this entire process.” He expressed the opinion that “the public has been given multiple opportunities to provide input ... and this is the way we intend it to work; it's a partnership between City government and the public to come to a final project that meets the needs of not only the City and
