PUBLIC COMMENTS

(5:32:30) – Capital City Arts Initiative's Sharon Rosse introduced the art in the Sierra Room and invited the Commissioners to a reception for Carson High School teacher and artist Mike Malley on Friday, September 9, 2016, 5-7 p.m. Ms. Rosse also invited the Commissioners to visit exhibitions on the second floor of the Carson City Courthouse and in the Community Development Building, and distributed related handouts which are incorporated into the record.

(5:35:34) – Ann Bollinger, Open Space Administrator, distributed a flyer, incorporated into the record, and invited the Commissioners and the public to celebrate the 20th anniversary of the Quality of Life Initiative at Silver Saddle Ranch. She noted that the free event included a concert by Mile High Jazz Band Association.

(5:36:52) – Patrick Lakers, a Cabriolet Drive, Carson City resident for three years, stated that off leash dogs in Carriage Square Park were being walked by residents and “people who don’t live in the area”. Mr. Lakers believed that the park did not allow dogs on or off leash and requested more patrols and enforcement. He also confirmed for Chairperson Keever that the City had placed new signs prohibiting dogs in the park, which were being ignored.

2. MODIFICATIONS TO THE AGENDA

3. MEETING ITEMS

A. INTRODUCTION OF STEVEN BRUNNER AS THE NEW PARKS AND RECREATION DEPARTMENT DEPUTY DIRECTOR.

(5:43:08) – Chairperson Keever introduced the item. Ms. Budge presented the Staff Report, incorporated into the record, and introduced Parks and Recreation Deputy Director Steve Brunner. Mr. Brunner also gave background on his 28-year career in the United States Marine Corps, per the attachment to the Staff Report. Commissioner Curtis noted that Mr. Brunner did not possess any background in parks and recreation and inquired about the type of training he would receive. Mr. Brunner ensured the Commission that he would be able to fulfil his duties, citing several certifications he planned to receive as quickly as possible.

(5:46:55) – Daniel Thompson introduced himself as a Carson City resident and spoke about “the Pickle Meadows area” Marine Installation, noting that Mr. Brunner was responsible for “the facilitation of all the open Forest Service land that all the marines were training on...”. 4. STAFF UPDATES - DISCUSSION ONLY

A. Update on James Glaser request for the City to provide reduced or free access for disabled veterans to all Parks and Recreation Department facilities.

(5:42:45) – Chairperson Keever introduced the item. Ms. Budge updated the Commission on her conversation with Mr. Glaser, who was “delighted” to hear that the discount provided to 100 percent disabled veterans to use the swimming pool would be extended to the usage of the Multi-purpose Athletic Center (MAC), adding that she had provided him with a new annual pass free of charge. She explained that Mr. Glaser would inform other 100 percent disabled veterans about these benefits, adding that he also wished to pursue different levels of discounts for different veterans’ disability levels, a potential benefit currently being reviewed by the District Attorney’s Office.
