The subject request is to allow Mr. Myungguan Kang to be the liquor manager. The applicant is now the sole owner of the restaurant. The subject business has a liquor license.

This request has been reviewed by the Sheriff's Office. The Sheriff's office conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.
