Subject: Update on Approved Façade Improvement Grant Applications

**RECOMMENDED RACC MOTION:** No action.

**DISCUSSION:**

At the last RACC meeting, a RACC member requested an update on the status of improvements previously approved under the Façade Improvement Program. This item is to provide that update on the status of projects and projected expenditure of funds.

A total of \$200,000 was allocated in FY 2017 for the Façade Improvement Program (FIP). To date, \$80,892 has been reimbursed to five improvement projects. Some projects were completed under the projected budget and the reimbursements were reduced, commensurately. There is \$77,285 allocated to pending projects, for a total of \$158,177 in spent or committed funds of the initial \$200,000 allocation. This will leave at least \$41,823 in unused funds that will carry forward as undesignated funds for this current fiscal year and/or future years.

Four of the five remaining approved projects have initiated improvements in compliance with the deadlines established for their projects. One approval, for 307 N. Carson Street (Garibaldi's Restaurant), has expired by inaction by the deadline. They could apply for a new application under the current funding year if they still wished to proceed with the project.
