SUBJECT: Liquor License: Slotworld – 3879 Hwy 50 E

Recommendation: To approve a liquor license for Silver Bullet of Nevada LLC dba Slotworld at 3879 Hwy 50 E with Michael Pegram as the liquor manager subject to the following condition of approval.

1. Mr. Pegram must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.
2. All items identified by the Health Department in its July 25, 2017 inspection must be corrected.

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code. The Hearings Officer considers the recommendation of the Sheriff's office and the Health Department in making his decision.

The subject request is to allow Silver Bullet of Nevada LLC dba Slotworld to have a liquor license, with Mr. Michael Pegram as the liquor manager. The applicant is seeking to operate an existing casino with a restaurant that serves beer, wine and liquor. The business is located at 3879 Hwy 50 E.

This request has been reviewed by both the Health Department and the Sheriff's Office. The Health Department inspected the premises and is recommending approval subject to:

1. All items identified by the Health Department in its July 25, 2017 inspection must be corrected.

The Sheriff's office waived the background check since a background check was completed within the last 6 months and did not find any disqualifying information based on CCMC 4.13.125.



Re: Liquor License-Slotworld 3879 Hwy 50 East and Slotworld Cabaret 324 E. Winnie Lane

On July 25, 2017 a routine inspection of Slotworld, located at 3879 Hwy 50 E. was conducted. If the violations noted in the most recent inspection, are corrected in a timely manner, the Carson City Health and Human Services would have no issue regarding a liquor license application approval for this business. However, an inspection of Slotworld Cabaret at 324 E. Winnie Lane was made on July 14, 2017 and it was not being operated in the way they had previously agreed to operate. They were told by Carson City Officials that they could sell only bottled beer and wine to customers using the gambling machines. On July 14, 2017 it was noted that beer from kegs and wine from boxes was being served to customers. There was no mop sink, three compartment sink, waste dump sink or hand wash sinks noted in the operation. The facility was not operating within the requirements of NAC 446, the Nevada Food and Drink Code.
