SUBJECT: Liquor License: Bless Up LLC (Liquor License #18-32318)

Recommendation: To approve a liquor license for Bless Up LLC at 2707 Hwy 50 East with Nitish Sachar as the liquor manager subject to the following condition of approval:

- 1. The applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.**

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code. The Hearings Officer considers the recommendation of the Sheriff's office and the Health Department in making his decision.

The subject request is to allow Bless Up LLC to have a liquor license, with Mr. Nitish Sachar as the liquor manager. The applicant is seeking to operate a convenience store with packaged liquor. The business is located at 2707 Hwy 50 East.

This request has been reviewed by both the Health Department and the Sheriff's Office. The Health Department inspected the premises is recommending approval.

The Sheriff's office conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.
