1. 1.1 Licensed Professionals- Vitality Unlimited employs a combination of licensed mental health professionals, licensed substance use professionals, certified substance use clinicians and para-professionals. For the calendar year 1Q2018, Vitality Carson City employed/Contracted with the following licensed professionals:
 - 1- Medical Director
 - 3-Licensed Clinical Alcohol and Drug Counselors
 - 1- Nurse Practitioner
 - 1- Registered Nurse
 - 1- License Certified Alcohol Drug/Marriage and Family Therapist (intern)
2. 1.8-1.10 Consent forms- Vitality Unlimited Intake Specialists and Specialty Court contacts have collaborated on appropriate referral and consent forms and associated procedures.
3. 1.3-1.5 Claims- Vitality is ensuring their Electronic Health Record and billing system has the ability to track and appropriately bill for services. There has been zero claims billed for services in 1Q2018 to either CPC or Specialty Courts.
