A. CALL TO ORDER

Mr. Plemel called the meeting to order at 10:00 a.m.

B. MODIFICATION TO THE AGENDA

There were no modifications to the agenda.

C. PUBLIC COMMENT

No public was present at this hearing.

D. PUBLIC HEARING: ACTION ITEM

D-1 FOR POSSIBLE ACTION: TO APPROVE A PACKAGED LIQUOR LICENSE FOR MEHARAASTHA, INC., DBA 7-ELEVEN #22629C AT 3701 N CARSON STREET WITH RAMAN ARORA AS THE LIQUOR MANAGER.

Mr. Plemel introduced the item and Ms. Ziegenbein presented the Staff Report which is incorporated into the record. She also noted that based on solicited input, the Health Department had no reported issues, and the Carson City Sheriff's Office had no disqualifying events in the last five years; therefore, she recommended approval - subject to a signed affidavit which had taken place prior to this meeting, and the completion of the server training course.

Mr. Draper, Mr. Arora, and Ms. Quigley introduced themselves and Mr. Plemel received confirmation that Mr. Arora had read and agreed with the conditions of approval. He also explained the hearing process and the City's policies regarding the sale of alcohol to minors, and the importance of the server training. Ms. Quigley noted that Mr. Arora had been a franchisee in the Bay Area and "had not had a problem there either" and that he now resides in Carson

City. Mr. Draper thanked the City for being cooperative and accommodating.

ACTION: Mr. Plemel approved a packaged liquor license for Meharaastha, Inc. dba 7-Eleven #22629C at 3701 N Carson Street, with Raman Arora as the liquor manager.

No public was present for comments.

F. ADJOURNMENT

Mr. Plemel adjourned the meeting at 10:37 p.m.
