**A. CALL TO ORDER**

Ms. Sullivan called the meeting to order at 1:15 p.m.

**B. MODIFICATION TO THE AGENDA**

Ms. Sullivan noted that item D-3 will be heard at a later date once the background check has been completed.

**C. PUBLIC COMMENT**

No public was present at this hearing.

**D. PUBLIC HEARING: ACTION ITEM**

**D-1 FOR POSSIBLE ACTION: TO APPROVE A COMBINATION PACKAGED AND "ON-PREMISE" LIQUOR LICENSE FOR PUNKY MONKIES, LLC DOING BUSINESS AS GATHER AT 402 N CARSON STREET WITH ANGELA BULLENTINI WOLF AS THE LIQUOR MANGER.**

Ms. Sullivan introduced the item and Ms. Ziegenbein presented the Staff Report which is incorporated into the record. She also noted that based on solicited input, the Sherriff' Health Department had no reported issues, and the Carson City Sheriff's Office had no disqualifying events in the last five years; therefore, she recommended approval, subject to the conditions of approval outlined in the Staff Report. Ms. Ziegenbein clarified that all alcohol must come from approved sources and could not be brewed or distilled on site.

Applicant Angela Bullentini Wolf noted that she had read the Staff Report and was in agreement with the conditions of approval outlined in the Staff Report. Ms. Sullivan emphasized the importance of server training and the consequences of serving alcohol to minors. She also received confirmation from Ms. Bullentini that the restaurant and farmers' market were co-located; however this approval was for the restaurant only.

**ACTION:** Ms. Sullivan approved the Combination Packaged and “On-Premise” liquor license for Punky Monkeys, LLC doing business as Gather, at 402 N Carson Street with Angela Bullentini Wolf as the liquor manger, subject to the conditions of approval outlined in the Staff Report.

Ms. Sullivan recessed the meeting at 1:20 p.m.

Ms. Sullivan reconvened the meeting at 1:30 p.m.

**D-2 FOR POSSIBLE ACTION: TO APPROVE A DINING ROOM WITH BEER AND WINE LIQUOR LICENSE FOR LA TANA, LLC, DOING BUSINESS AS MANGIA TUTTO AT 200 N. STEWART STREET WITH CATHERINE ROLEWICZ AS THE LIQUOR MANAGER.**
