Recommendation: To approve a General Wholesale liquor license for Regency Wines Nevada at 10 Greg St Suite 124 Sparks, NV, with Bruno Laclotte as the liquor manager.

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is to allow Regency Wines Nevada to have a General Wholesale liquor license, with Bruno Laclotte as the liquor manager. The business is located at 10 Greg St Suite 124 Sparks, NV. Per CCMC 4.13.070, the applicant has provided proof of valid liquor license in Sparks, NV, where its primary business is located. The proposed liquor manager, Bruno Laclotte is also the liquor manager in Sparks, NV.

Per Carson City Municipal Code 4.13.070 no background investigation is required for wholesale dealers that conduct business, but do not have a physical business location, in Carson City.
