Re: Flood Zone Determination for APN-004-012-28.

Dear Mr. Pelfrey:

The intent of this letter is to clarify the FEMA flood zone designation for the above mentioned parcel.

As shown on a Flood Insurance Rate Map 320001 0080C dated March 16, 1989 referenced property is partially located within a "AH" zone and partially within a "C" zone (see attachment).

Per zone designation:

Zone AH - areas of 100-year shallow flooding where depths are between one (1) and three (3) feet; base flood elevation are shown on a map, but no flood hazard factors are determined;

Zone C - areas of minimal flooding.

Since our office doesn't have an Elevation Certificate for the subject parcel, to obtain additional information regarding BFE (Base Flood Elevation) relative to the finished floor of the existing building you will need the assistance of professional surveyor and use a Flood Insurance Study.
