A special meeting of the Carson City Board of Supervisors was held on Tuesday, November 14, 2006, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 11:30 a.m.

CALL TO ORDER, ROLL CALL, AND PLEDGE OF ALLEGIANCE - Mayor Teixeira convened the meeting at 11:30 a.m. Roll call was taken. The entire Board was present, constituting a quorum.

PUBLIC COMMENTS AND DISCUSSION (11:28:15) - None.

1. CLERK/RECORDER - ACTION TO APPROVE THE CANVASS OF THE VOTE AS PRESENTED BY THE CLERK/RECORDER FOR THE 2006 GENERAL ELECTION (11:28:20) - Clerk-Recorder Alan Glover introduced the item and thanked his staff including the hourlies and individuals who had worked during early voting periods, the Parks and Recreation employees, the Community Center staff, and the 115 individuals who had worked on election day. They had performed admirably and completed their tasks in a competent manner. Discussion noted that Douglas County may have the honor of having the oldest person working on election day, however, Carson City had some that had worked at the polls for more than 20 years. It was also felt that some of the individuals were close to the age of the individual in Douglas County. It was one of the smoothest elections Mr. Glover had operated. There were very few problems. The weather was great. Turnout for the early elections totaled 8,528 votes or 33% of the voters. Absentee voting and voter turnout on election day were described. More individuals are registered to vote than there were four years ago. Supervisor Staub congratulated Supervisors Williamson and Livermore on their successful campaign. Discussion indicated that the swearing-in ceremony will be low key and held in District Court 2 chambers on January 1 at 9 a.m. A formal announcement will be made after Governor Guinn selects the new District Judge. Supervisor Aldean moved that the Board of Supervisors approve the canvass of the vote for the 2006 General Election and the canvass of the vote for the 2006 Carson City School Bond election as presented by the Clerk-Recorder. Supervisor Staub seconded the motion. Motion carried 5-0.

Mr. Glover explained the School District Canvass Resolution. Supervisor Aldean moved to adopt Resolution No. 2006-R-39, A RESOLUTION DESIGNATED BY THE SHORT TITLE "2006 CARSON CITY SCHOOL DISTRICT CANVASS RESOLUTION"; DECLARING THE RESULTS OF AN ELECTION HELD WITHIN CARSON CITY SCHOOL DISTRICT IN CARSON CITY IN THE STATE OF NEVADA ON THE GENERAL OBLIGATION SCHOOL BOND QUESTION SUBMITTED AT THE ELECTION HELD ON TUESDAY, NOVEMBER 7, 2006, TO THE QUALIFIED ELECTORS OF THE DISTRICT; PROVIDING OTHER MATTERS RELATING THERETO; AND PROVIDING THE EFFECTIVE DATE

HEREOF. Supervisor Staub seconded the motion. Supervisor Williamson complimented the electorate for approving the School Bond. Mayor Teixeira noted that it would not increase the property taxes. He also complimented the voters for approving the Bond. The motion was voted and carried 5-0.

2. ACTION TO ADJOURN (11:36:05) - There being no other matters for consideration, Supervisors Aldean and Staub moved to adjourn. Supervisor Williamson seconded the motion. Motion carried 5-0. Mayor Teixeira adjourned the meeting at 11:37 a.m.
