A special meeting of the Carson City Board of Supervisors was held on Thursday, August 25, 1988, at the Community Center Sierra Room, 851 East Williams Street, Carson City, Nevada, beginning at 4 p.m.

NOTE: Unless otherwise indicated, each item was introduced by staff's reading/outlining/clarifying the Board Action Request and/or supporting documentation. Staff members present for each Department are listed under that Department's heading. A tape recording of these proceedings is on file in the Clerk-Recorder's office. This tape is available for review and inspection during the normal business hours.

Mayor Pro-Tem Scrivner called the meeting to order at 4 p.m. Roll call was taken and a quorum was present although Mayor Flammer was absent.

1. CARSON CITY COMPREHENSIVE WATER PLAN, PRISON FARM IRRIGATION PHASE II, CONTRACT I-2, CHANGE ORDER NO. 2, A & K EARTHMOVERS, INC. (1-0031) - The work was 85 percent grant eligible. Jim Vasey of Vasey Engineering explained the change order. Supervisor Swirczek moved that the Board approve Change Order No. 2 to Contract I-2 with A & K Earthmovers, Inc., increasing the amount of the contract by \$6,823 and authorize the Mayor to sign, funding source Fund 510, and that the amount not exceed \$6,823. Supervisor Fettic seconded the motion. Motion carried 4-0.

2. AUTHORIZE TREASURER TO SEEK BANK FINANCING FOR IMPROVEMENTS AT CARSON CITY WASTEWATER TREATMENT PLANT (1-0019) - Mr. Hamilton explained the grant funding restrictions and the need to obtain any bond funds necessary to complete the project before the electorate approved bonding capacity expires. The plant may be completed within 20 months. The proposed resolution only authorized the Treasurer to seek bids from banks for an amount not to exceed \$750,000. On September 8th the Board will consider an ordinance authorizing the sale of bonds. At that time the actual amount necessary to complete the project should be known. If the appeal of the grant restrictions is fruitful or the amount is not needed due to other funding sources, the bids would be rejected. The bond protest period is two weeks. (1-0295) Mr. Thornton explained the anticipated rate of interest for Earl Milliken. The funds will be invested until needed. If the bonds are not sold and the funds are later needed to complete the project, the sewer fund would have to pay and which may require an increase in fees. Supervisor Swirczek moved to adopt Resolution No. 1988-R-53, A RESOLUTION AUTHORIZING THE TREASURER TO SEEK BANK FINANCING FOR THE IMPROVEMENTS OF THE CARSON CITY WASTEWATER TREATMENT PLANT IN AN AMOUNT NOT TO EXCEED \$750,000. Supervisor Fettic seconded the motion. Motion carried 4-0.
