D-1 FOR POSSIBLE ACTION: TO APPROVE A DINING ROOM WITH A HARD LIQUOR LICENSE FOR ANTONIO ORTEGA-AVILA DBA MARIA'S MEXICAN RESTAURANT AT 1939 N. CARSON ST WITH ANTONIO ORTEGA-AVILA AS THE LIQUOR MANAGER.

Mr. Plemel introduced the item and Ms. Sullivan presented the Staff Report which is incorporated into the record.

Applicant Antonio Ortega-Avila acknowledged that he had purchased an existing business. He also noted that he had read the Staff Report and was in agreement with the outlined conditions of approval. There were no public comments.

Mr. Plemel stressed the importance of server training, and reviewed the consequences and the penalties of serving to minors.

ACTION: Mr. Plemel approved the dining room with a hard liquor license for Antonio Ortega-Avila dba Maria's Mexican Restaurant at 1939 North Carson Street with Antonio Ortega-Avila as the liquor manager subject to the conditions of approval noted in the Staff Report.
