**D-1 FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION FOR RELOCATION OF A DINING ROOM WITH BEER AND WINE LIQUOR LICENSE FOR JUAN ANTONIO REA-MARISCAL, MARIA CANO DE REA, AND ANTONIO CANO DBA NATIONAL'S CAFE FROM 1701 N. CARSON STREET TO 444 E. WILLIAM STREET #6 WITH JUAN ANTONIO REA-MARISCAL REMAINING AS THE LIQUOR MANAGER..**

Mr. Plemel introduced the item. Ms. Sullivan presented the Staff Report which is incorporated into the record and noted that Mr. Rea-Mariscal was already in possession of a beer and wine liquor license and that he had already taken the server training class; therefore this approval was for the restaurant location change. She also confirmed for Mr. Plemel that there were no prior citations of which they were aware. Mr. Plemel explained the consequences of serving to minors and the penalties of the new violations. Both Mr. Rea-Mariscal and Mr. Cano acknowledged their agreement to the conditions of approval. There were no public comments.

**ACTION:** Mr. Plemel approved the relocation of a dining room with beer and wine liquor license for National's Cafe from 1701 N. Carson Street to 444 E. William Street #6 with Juan Antonio Rea-Mariscal remaining as the liquor manager.
