Thank you for sharing the layout of the Eagle Valley Middle School. I was not aware of the 2 storage containers you highlighted beside the track. I visited there (up to the fence) today and found only 1 storage container there now. I am attaching a picture from just outside the gate and fenced area and it is a bit far off but I think you can confirm only 1 container there.

I also took a picture from my back yard over my fence and you can see that there are 2 containers in that location On the drawing you sent me that location is adjacent to the circular drive turn around on the east side of the campus.

So my original question still exists. Does the school have the ability to locate a second container in the area near the circular drive, which is clearly visible to my and other properties along that boundary? I do remember being notified at some time in the past that the school was seeking permission to extend the permit to have a single storage container in that location. I did not complain then but I did contact the school and requested they remove the graffiti from the container. They did that and all has been acceptable until the second container showed up.

I do not like having another container in my view and would like the school to remove it and perhaps put it back where it came from.

Please let me know if there is any answer to my concerns.
