#### 4. MEETING ITEMS

##### **4.A FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION TO MAKE A RECOMMENDATION TO THE REDEVELOPMENT AUTHORITY REGARDING THE EXPENDITURE OF \$44,754 FROM THE FISCAL YEAR 2019 REDEVELOPMENT REVOLVING FUND FOR IMPROVEMENTS TO THE FUJI PARK FAIRGROUNDS SOUND SYSTEM, LOCATED AT 601 OLD CLEAR CREEK ROAD.**

(4:33:15) – Chairperson Cardinal introduced the item. Mr. Plemel presented the Staff Report and highlighted the information that the Redevelopment Authority had originally allocated \$100,000 in FY 2020 to replace the sound system at the Fuji Park Fairgrounds, however, during the 2019 review of the FY 2020 Redevelopment budget allocations, the Redevelopment Authority had approved shifting the \$100,000 in funding to the current fiscal year's budget (FY 2019) in order to replace the sound system as soon as possible for the 2019 summer event season. Subsequently, according to Mr. Plemel, the Bob Boldrick Theater sound system improvements were moved from FY19 to FY20, beginning in July 1, 2019. Mr. Plemel also indicated that the City had received two quotes, and that the lower amount of \$44,754 met the needs of the facility and the Parks, Recreation, and Open Space Department. He further noted that the amount would be paid through the Redevelopment Revolving Fund which must be approved by the Redevelopment Authority and the Board of Supervisors, upon recommendation from the RACC.

(5:35:44) – Mr. Plemel clarified that this item was agendized to be heard by the Redevelopment Authority during the Thursday, June 6, 2019 Board of Supervisors' meeting, at which time he would convey the RACC's recommendation. Chairperson Cardinal thanked Mr. Plemel and all involved in obtaining a much lower bid that budgeted. Member Smith inquired about any local companies that had been provided the opportunity to bid on the project. Community Center Program Manager Eric Klug clarified that no audio companies were present in Carson, and that they were located in Gardnerville, Reno, or Sparks. Chairperson Cardinal entertained public comments, and when none were forthcoming, a motion.

**(5:37:18) – MOTION: I move to recommend to the Redevelopment Authority approval of the expenditure of up to \$44,754 for the Fairgrounds sound system.**
