A. CALL TO ORDER

Mr. Plemel called the meeting to order at 1:30 p.m.

D. PUBLIC HEARING: ACTION ITEM

D-1 FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION TO APPROVE A LIQUOR LICENSE WITH AMBER PRICE AS THE LIQUOR MANAGER FOR A TAVERN/BAR FOR NORTHERN NEVADA HERITAGE LLC, DOING BUSINESS AS THE LIGHTHOUSE BAR AT 4750 E HIGHWAY 50 SUITE 1.

Mr. Plemel introduced the item. Ms. Somers presented the Staff Report, incorporated into the record, and reported that the Health Department had inspected the premises and had recommended approval. Similarly, a background check by the Carson City Sheriff's Office had not found any disqualifying information in the last five years. Ms. Somers recommended approval, subject to the signing of an affidavit and the completion of a server training course.

Mr. Plemel stressed the importance of server training and explained the consequences of serving to minors. Ms. Price explained that she had experience working in a bar and noted that most of the employees would be family members. She also acknowledged reading and was in agreement with the conditions of approval.

ACTION: Mr. Plemel approved the application for a liquor license with Amber Price as the liquor manager for a Tavern/Bar for Northern Nevada Heritage LLC, doing business as The Lighthouse Bar at 4750 E

Highway 50 Suite 1.
