at 308 N Curry St. (Liquor License # #20-32574)

Recommendation: To approve a change of liquor manager of a Dining Room with Hard Liquor for The Martin Carson LLC, dba Cucina Lupo. Tanya McCaffery will be taking over as the liquor manager subject the following conditions of approval:

1. The applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.
2. Serving of alcohol must come from approved sources.
3. No changes to bar set up may be made without approval from health authority.
4. Proper handwashing sinks and dump sinks must be present per Health Department.
5. Business must adhere to the FDA Food Code and NAC 446 for operational purposes.

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is to allow The Martin Carson LLC, dba Cucina Lupo located at 308 N Curry Street to replace their liquor manager with Tanya McCaffery as the new liquor manager.

This request has been reviewed by both the Health Department and the Sheriff's Office. The Health Department inspected the premises and is recommending approval based on the above conditions being met.

The Sheriff's office conducted a background check in 2017 and did not find any disqualifying information in based on CCMC 4.13.125.
