Liquor and Entertainment Board
Policy on Attendance of Liquor License Applicant**

POLICY STATEMENT

The Carson City Liquor and Entertainment Board is the body of Carson City government that is empowered to approve liquor license applications. CCMC 4.13.100 (2) states that "The applicant or applicants shall appear before the board at the appointed time for approval or denial of the license." This requirement shall be deemed to be met if the person appearing before the board is either the applicant, an attorney representing the applicant or a person having a limited power of attorney specifying him as representing the applicant in Carson City liquor license affairs.

PURPOSE

The purpose of this policy is to enact reasonable rules and regulations enabling a more business friendly and cooperative attitude.

IMPLEMENTING PROCEDURES

The person who comes before the Liquor and Entertainment Board must either identify themselves as the applicant, the applicant's attorney or submit to the liquor license administrator a current power of attorney naming said person as having the authority to represent the applicant before the board.
