A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, February 1, 2007, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

**ACTION ON APPROVAL OF MINUTES - 11/2/06 (8:42:50)** - Member Aldean moved to approve the Minutes of the Carson City Liquor and Entertainment Board dated November 2, 2006, as presented. Members Williamson and Livermore seconded the motion. Motion carried 6-0.

**A. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR MR. GURMUKH SINGH BADHAN, OWNER OF THE LUCKY 7 BAR, LOCATED AT 1914 NORTH CARSON STREET (8:43:11)** - Gurmukh Badhan -Mr. Badhan indicated that he had purchased the establishment. Member Furlong indicated that the Sheriff's Office did not object to Mr. Badhan's having a Liquor License. Chairperson Teixeira stressed the importance of adhering to the Liquor Laws and not serving minors. Member Williamson moved to approve a full bar liquor license for Mr. Gurmukh Singh Badhan, owner of the Lucky 7 Bar, located at 1914 North Carson Street; fiscal impact is \$1,000 for original new fee, \$500 for an investigation fee, and \$200 for a quarterly fee. Member Aldean seconded the motion. Motion carried 6-0.

**B. ACTION TO APPROVE A FULL BAR (ON PREMISE AND PACKAGED)**

**LIQUOR LICENSE FOR CAIE GEORGE, MEMBER AND LIQUOR MANAGER OF CAIE'S CARSON CITY CAFÉ, LTD., DOING BUSINESS AS CAIE'S ORIENTAL CAFÉ, LOCATED AT 301 NORTH CARSON STREET (8:44:56)** - CaiE George - Discussion indicated that Ms. George has two restaurants in Reno. The plan is to have an upscale fast food establishment that serves oriental food. She hoped to open soon. Member Furlong indicated that the Sheriff's Office has no objections to her having a license. Discussion indicated that she had applied for a full bar liquor license and would be able to serve liquor on premise or sell it as packaged liquor for takeout. Clarification explained that her intent is to have only beer and wine but the license would allow the sale of hard liquor. The restaurant will utilize the patio area. Amenities and the ambience proposed for the restaurant were described. Ms. George expressed her intent to have the restaurant franchised with more of them in the area. Chairperson Teixeira and Member Williamson thanked her for her investment in the community. Chairperson Teixeira encouraged her to uphold the Liquor Laws and those specifically related to minors. Clarification by Member Furlong indicated for the record that the Liquor License is for on-premise and packaged beer and wine sales. Chairperson Teixeira indicated that she could upgrade the license in the future, if desired. Hard liquor will not be allowed under this license. Ms. George then indicated that she hopes to open by 3/26 or 3/27. The proposed opening ceremonies were described. Member Aldean moved to approve a packaged beer and wine liquor license and a dining room beer and wine license for CaiE George, member and liquor manager of CaiE's Carson City Café, Limited, dba CaiE's Oriental Café, located at 301 North Carson Street; fiscal impact is \$500 for the original new fee, \$500 for an investigation fee, and \$225 for a quarterly fee. Member Livermore seconded the motion. Motion carried 6-0.

There being no other matters for consideration, Chairperson Teixeira adjourned the Liquor and Entertainment Board.
