A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, February 2, 2006, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

Mayor Teixeira recessed the Board of Supervisors session and immediately convened the Liquor and Entertainment Board by noting that there was a quorum present, including Member Furlong. Member Aldean was absent. For Minutes of the Board of Supervisors, see its folder for this date.

A. ACTION ON APPROVAL OF MINUTES - DECEMBER 1, 2005 (9:05:38) - Member Livermore moved for approval of the December 1, 2005, Minutes as presented. Members Williamson and Staub seconded the motion. Motion carried 5-0.

B. ACTION TO APPROVE A COMBO (ON-PREMISE AND PACKAGED) LIQUOR LICENSE FOR HMAV, LLC, DOING BUSINESS AS VIDEO CENTRO MINI-MART, WITH HERBERTO MURO AS LIQUOR MANAGER, LOCATED AT 2765 HIGHWAY 50 EAST (9:06:01) - Herberto Muro indicated that he owns the business and that this is his first liquor license. The Sheriff's investigation has been completed and found no objections to granting him a license. Mr. Muro explained that at this time he plans to sell only on premise liquor. In the future he may serve alcohol for off premise use. Chairperson Teixeira cautioned him against selling to minors and explained the City's serious position regarding the granting of a liquor license. Mr. Muro indicated an intent to work with the City and do a good job. Member Williamson moved to approve a combo on-premise and packaged liquor license for HMAV, LLC, doing business as Video Centro Mini-Mart, with Herberto Muro as Liquor Manager, located at 2765 Highway 50

East, fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$225 quarterly fee. Member Livermore seconded the motion. Motion carried 5-0.

C. ACTION TO APPROVE A REQUEST BY THE TREASURER TO HAVE AN INVESTIGATION CONDUCTED OF THE LIQUOR LICENSE HELD BY GENE AND KAREN FAIRL, DOING BUSINESS AS FAIRL'S COUNTRY SALOON, TO DETERMINE WHETHER GROUNDS EXIST FOR REVOCATION OF THEIR LIQUOR LICENSE (9:07:48) - Chief Deputy Steve Schutte indicated that the information provided in the Board's packet was incomplete. Copies of additional information were provided to the Board. (A copy was not given to the Clerk.) There have been 138 calls to the establishment during a one year period. A comparison of its calls with similar establishments was purportedly included in the packet of information provided to the Board. The establishment is dominating Patrol Deputies' time. The request is for direction to proceed with an investigation. Discussion between Member Staub and Chief Deputy Schutte indicated that the taxpayers will pay for the investigation. Member Staub suggested that the Code be rewritten to make the business responsible for the costs of an investigation. Chairperson Teixeira explained that the Board does not have this ability at this time. Other options, however, are available and should be pursued. A Code revision can be made later. He did not want the investigation to be delayed. Member Livermore moved to approve a request to have an investigation conducted of the liquor license held by Gene and Karen Fairl, DBA Fairl's Country Saloon, to determine whether grounds exist for revocation of their liquor license. Member Staub seconded the motion. Motion carried 5-0.

There being no other matters for consideration as the Liquor and Entertainment Board, Chairperson Teixeira adjourned the Liquor and Entertainment Board session.
