Mayor Teixeira recessed the Board of Supervisors session and immediately convened the Liquor and Entertainment Board by noting a quorum was present, including Member Furlong. (For the Board of Supervisors Minutes, see its folder for this date.)

ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR LEFTY'S DINER, LLC, DBA LEFTY'S COMSTOCK DINER, LOCATED AT 3680 GONI ROAD, WITH TIM MCCONNELL AS LIQUOR MANAGER (1-0110) - Treasurer Al Kramer - Tim McConnell indicated that he is the manager/operator/owner. This is his first liquor license, however, he has been in the restaurant business for 30 years. He acknowledged his responsibility to assure that the establishment does not sell liquor to minors. Chairperson Teixeira reminded him that the Sheriff's Office periodically conducts sting operations. The Department also has the right to enter the premise during business hours when performing their law enforcement duties. Member Furlong indicated that the Sheriff's Department had completed its investigation and did not object to his licensing. Mr. McConnell explained his reasons for wanting a liquor license. Member Aldean explained her knowledge of his work experience at Heidi's. She welcomed him to the community. Member Aldean moved to approve a full bar liquor license for Lefty's Diner, LLC, dba Lefty's Comstock Diner, located at 3680 Goni Road with Tim McConnell as liquor manager, fiscal impact is \$1,000
