A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, April 7, 2005, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

Mayor Teixeira recessed the Board of Supervisors and immediately convened the Liquor and Entertainment Board by noting that there was a quorum present, including Member Furlong. For the Minutes of the Board of Supervisors meeting, see its folder for this date.

1. APPROVAL OF MINUTES - 9/2/04 AND 3/3/05 (1-0125) - Member Aldean moved to approve the Minutes from the September 2, 2004, and March 3, 2005, meetings of the Carson City Liquor and Entertainment Board meetings. Member Livermore seconded the motion. Motion carried 6-0.

OTHER MATTERS (1-0132) - Chairperson Teixeira explained his need to attend a Legislative session and passed the gavel to Vice Chairperson Williamson. Chairperson Teixeira left the meeting at 8:38 a.m. A quorum was still present.

2. TREASURER - Al Kramer

A. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR KEVIN DUNCAN, DOING BUSINESS AS JAVELINS, LOCATED AT 306 E WILLIAM STREET (1-0132) - Vice Chairperson Williamson reminded Mr. Duncan of his responsibilities to train his employees and not serve minors. Mr. Duncan acknowledged his responsibilities. Member Aldean moved to approve a full bar liquor license for Kevin Duncan, DBA Javelins, located at 306 East William Street; fiscal impact is \$1,000 original new fee, \$500 investigation fee; and \$200 quarterly fee. Member Livermore seconded the motion. Motion

carried 5-0-1 with Chairperson Teixeira absent.

B. ACTION TO APPROVE A BEER AND WINE LICENSE FOR MATTHEW INGRAM AND THOMAS BLAISDELL, DBA PIZZA FACTORY OF CARSON CITY, LOCATED AT 3120 HIGHWAY 50 EAST (1-0182) - Vice Chairperson Williamson reminded them of their responsibilities. Messrs. Ingram and Blaisdell agreed to abide by the Liquor Laws. Member Aldean moved to approve a beer and wine license for Matthew Ingram and Thomas Blaisdell, DBA Pizza Factory of Carson City, located at 3120 Highway 50 East; fiscal impact is \$500 original new fee; \$575 investigation fee; and \$150 quarterly fee. Member Livermore seconded the motion. Motion carried 5-0-1 with Chairperson Teixeira absent. Discussion indicated that they plan to open at the end of May.

C. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR LOYOLA ALEGUNDO AND ARMANDO GUZMAN, DBA EL MARIACHI LOCO, LOCATED AT 557 SOUTH SALIMAN ROAD (1-0209) - Vice Chairperson Williamson reminded them of their responsibilities. The Applicants indicated that they are familiar with the Liquor Laws. Member Aldean moved to approve a full bar liquor license of Loyola Alegundo and Armando Guzman, DBA El Mariachiloco located at 557 South Saliman Road; fiscal impact is \$1,000 original new fee, \$575 investigative fee, and \$200 quarterly fee. Member Livermore seconded the motion. Member Furlong indicated that the Sheriff's Investigative Reports had supported licensing all of the applicants. Motion carried 5-0-1 with Chairperson Teixeira absent.

D. ACTION TO APPROVE A BEER AND WINE LICENSE FOR JINGXIAN JIA AND CHAN PONG TAN DBA HUNAN GARDEN, LOCATED AT 1480 NORTH CARSON STREET (1-0245) - Vice Chairperson Williamson reminded them of their responsibilities. Discussion indicated that the Applicants plan to open for business at the end of April. They also indicated that they will have someone on the premise who understands, speaks and reads English. Member Furlong indicated that the Sheriff's Office had no concerns about licensing the applicants. Member Aldean apologized for her pronunciation of their names and moved to approve a beer and wine license for Jingxian Jia and Chan Pong Tan, DBA Hunan Garden, located at 1480 North Carson Street; fiscal impact is \$500 original new fee, \$575 investigation fee, and \$150 quarterly fee. Member Livermore seconded the motion. Motion carried 5-0-1 with Chairperson Teixeira absent.

E. ACTION TO APPROVE A PACKAGED LIQUOR LICENSE FOR JULIE VINCENT, DBA J&J GAS AND CONVENIENCE MARKET, LOCATED AT 4340 NORTH CARSON STREET (1-0278) - Vice Chairperson Williamson reminded her of her responsibilities. Member Furlong indicated the Sheriff's Office has no concerns with licensing the applicant. Member Aldean moved to approve a packaged liquor license for Julie Vincent, DBA J&J Gas and Convenience Market located at 4340 North Carson Street; fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$200 quarterly fee. Member Livermore seconded the motion and welcomed her to the Medical College Parkway. Comments indicated that a traffic signal is "on its way" to that intersection. The motion was voted and carried 5-0-1 with Chairperson Teixeira absent.

F. ACTION TO APPROVE A COMBO (ON-PREMISE AND PACKAGED) LIQUOR LICENSE FOR STEVE VINALL, DBA RE-BAR, LOCATED AT 1305 SOUTH CARSON STREET (1-0309) - Vice Chairperson Williamson reminded him of his responsibilities. Mr. Vinall indicated that he understood. Discussion indicated that the firm's business name is Re-Bar. Member Aldean pointed out that

this is the second combined license the City has issued. Member Aldean moved to approve a combined on-premise and packaged liquor license for Steve Vinall, DBA Re-Bar, located at 1305 South Carson Street; fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$225 quarterly fee. Member Livermore seconded the motion. Member Furlong indicated the Sheriff's Office had no concerns with licensing the applicant. The motion carried 5-0-1 with Chairperson Teixeira absent.

There being no other matters for consideration as the Liquor and Entertainment Board, Vice Chairperson Williamson adjourned the Liquor and Entertainment Board.
