A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, May 5, 2005, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

APPROVAL OF MINUTES - 4/21/05 AND 10/7/04 (1-0058) - Member Williamson moved to approve the Minutes of the Carson City Liquor and Entertainment Board for April 21, 2005, and October 7, 2004, with a correction to the April 21, 2005, concerning the Chairperson and Vice Chairperson. Member Livermore seconded the motion. Motion carried 6-0.

TREASURER

A. ACTION TO APPROVE A COMBO LIQUOR LICENSE FOR MULLIGAN'S, INC., DBA MULLIGAN'S FOOD, FUN & SPIRITS, WITH NATHAENIAL LANCE AND DAMON GEORGE AS LIQUOR MANAGERS, LOCATED AT 2300 HWY 50 EAST (1-0074) - Nathaenial Lance and Damon George - Discussion noted that a representative from the Treasurer's office was not present. Chairperson Teixeira explained the location of the establishment. Both of the applicants indicated that they had been in the business previously. Member Furlong indicated that the Sheriff's Office did not object to the

licensing. Chairperson Teixeira reminded them not to serve alcoholic beverages to minors. Member Staub explained for the record that he had met Mr. George when he had tried to ride a motorcycle. He asked Mr. George to say hello to his father for him. Member Staub moved to approve a combo liquor license for Mulligan's, Inc., doing business as Mulligan's Food, Fun and Spirits, with Nathaenial Lance and Damon George as Liquor Manager, located at 2300 Highway 50 East; fiscal impact is \$1,000 original new fee, \$575 investigation fee, and \$225 quarterly fee. Member Aldean seconded the motion. Motion carried 6-0. The Applicants explained their hope that they will be able to open by mid-June. Reasons for the delay in opening were noted. The establishment will be an Irish sports bar with four signature Irish food items in addition to the normal hamburgers, salads, wings, etc., food items found in sports bars.

B. ACTION TO APPROVE A BEER AND WINE LICENSE FOR JUNE JOPLIN, DBA COMMA COFFEE, LOCATED AT 312 S. CARSON STREET (1-0125) - June Joplin indicated that she owns the business. The request is for a beer and wine license. Member Furlong indicated the Sheriff's Office had no objections to her license. Member Aldean moved to approve a beer and wine license for June Joplin, dba Comma Coffee, located at 312 South Carson Street; fiscal impact is \$500 original new fee, \$500 investigation fee, and \$150 quarterly fee. Member Williamson seconded the motion. Motion carried 6-0. Ms. Joplin described the entertainment scheduled for this evening and invited the Board and public to attend.

There being no other matters for consideration, Chairperson Teixeira adjourned the Liquor and Entertainment Board.
