A meeting of the Carson City Liquor and Entertainment Board was held during the Carson City Board of Supervisors session on Thursday, May 19, 2005, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 8:30 a.m.

Mayor Teixeira recessed the Board of Supervisors and immediately convened the Liquor and Entertainment Board by noting that there was a quorum present, including Member Furlong. For Minutes of the Board of Supervisors, see its folder for this date.

**TREASURER - Al Kramer**

**A. ACTION TO APPROVE A REINSTATEMENT AND TRANSFER OF A FULL BAR LIQUOR LICENSE FOR EL AGUILA REAL, INC., WITH JOSE SANCHEZ AS LIQUOR MANAGER, LOCATED AT 3220 HIGHWAY 50 EAST (1-0282)** - Jose Sanchez explained the location and the request to transfer the license from one site to another. Member Furlong indicated that the Sheriff's Office had verified the information and that they had no concerns. Discussion between the Board and Mr. Kramer indicated that a Liquor License could remain dormant for a year before a higher fee is required. Member Williamson moved to approve a reinstatement and transfer of a full bar Liquor License for El Aguila Real, Inc., with Jose Sanchez as liquor manager, located at 3220 Highway 50 East. Member Livermore seconded the motion. Motion carried 6-0. Discussion indicated that the establishment will open on June 1<sup>st</sup> and will be able to accommodate 100 people at a time. The location of Mr. Sanchez' other establishments were listed. The Board wished him success at his new location.

**B. ACTION TO APPROVE A WHOLESALE LIQUOR DISTRIBUTOR LICENSE FOR GREAT BASIN BEVERAGE RENO, LLC, WITH ALAN AND STEPHANIE BLACH AS LIQUOR MANAGERS, LOCATED AT 2399 VALLEY ROAD, RENO, NEVADA (1-0314)** - Alan and Stephanie Blach explained their acquisition of Luce and Sons Distributing in Reno. Great Basin Spirits, which is located in Sparks, is not part of their business. They will be wholesalers and not offer any other service. Member Furlong noted the Sheriff's background check was favorable. The applicants have been in business for 59 years. Member Aldean moved to approve a wholesale liquor distributor license for Great Basin Beverage Reno, LLC, with Alan and Stephanie Blach as liquor managers, located at 2399 Valley Road, Reno, Nevada,

fiscal impact is \$1,000 original new fee, \$575 investigation fee, and \$200 quarterly fee. Member Williamson seconded the motion. Motion carried 6-0.

**CITIZEN COMMENTS (1-0354)** - Al Kramer explained that Nevada Treasurer Brian Krolichi had deputized him to represent Treasurer Krolichi in the distribution of ballots for the State quarter. Anyone residing in the State is eligible to vote. Locations where ballots could be obtained were listed. They may be mailed to the office. A ballot is on the Treasurer's web page. Its address was provided. The deadline for submittal of the ballot is May 30.

There being no other matters for consideration, Chairperson Teixeira adjourned the Liquor and Entertainment Board.
