A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, December 1, 2005, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

Mayor Teixeira recessed the Board of Supervisors and immediately convened the Liquor and Entertainment Board by noting that there was a quorum present, including Member Furlong. For Minutes of the Board of Supervisors, see its folder for this date.

A. ACTION TO APPROVE A BEER AND WINE LICENSE FOR S&T INTEGRITY ENTERPRISES, LLC, DBA KIM LEE'S SUSHI AND TERIYAKI, WITH TIMOTHY AND SIGRID KILGORE AS LIQUOR MANAGERS, LOCATED AT 111 E TELEGRAPH STREET (8:35:45) - Treasurer Al Kramer, Timothy and Sigrid Kilgore - Discussion indicated that the application was for a change of ownership. The Kilgores had lived in the area 14 years ago. Chairperson Teixeira stressed the importance of checking the identification for minors. Member Furlong advised that the Sheriff's Department found no problems with licensing the applicants. Member Williamson moved to approve a beer and wine license for S&T Integrity Enterprises, LLC, doing business as Kim Lee's Sushi and Teriyaki with Timothy and Sigrid Kilgore as Liquor Managers located at 111 East Telegraph Street, and the fiscal impact is \$500 original new fee, \$575 investigation fee, and \$150 quarterly fee. Member Aldean seconded the motion. Motion carried 6-0. Mr. Kilgore advised of their intent to keep the business as it is and add delivery service to it. Discussion indicated that the brewery equipment is still in the building, however, they have no plans to use it.

B. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR JASON SWEET DBA CUE-PHORIA BILLIARDS, LOCATED AT 55 EAST WINNIE LANE (8:38:04) - Treasurer Al Kramer, Jason

Sweet - Mr. Sweet advised that he had been in the landscaping maintenance business and had never owned a bar before. Chairperson Teixeira reiterated the need to check identification cards and to prevent minors from obtaining liquor. He reminded Mr. Sweet that minors will and do frequent the establishment. Member Furlong indicated that the Sheriff's Investigation had been completed and found no problems with granting Mr. Sweet a license. Member Aldean moved to approve a full bar liquor license for Jason Sweet dba Cuephoria Billiards located at 55 East Winnie Lane and the fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$200 quarterly fee. Member Williamson seconded the motion. Motion carried 6-0. Chairperson Teixeira wished him success.

There being no other matters for consideration by the Liquor and Entertainment Board, Chairperson Teixeira adjourned the Liquor and Entertainment Board.
