Mayor Masayko recessed the Board of Supervisors session and immediately convened the Liquor and Entertainment Board by noting that a quorum was present, including Sheriff's Representative Schutte. For Minutes of the Board of Supervisors session, see its folder for this date.

TREASURER - Al Kramer - ACTION TO APPROVE A FULL PACKAGED LIQUOR LICENSE FOR GREG PSILOPOULOS, DBA ALOHA DISCOUNT LIQUOR, LOCATED AT 4555 SOUTH CARSON STREET (1- 0615) - Chairperson Masayko welcomed Mr. Psilopoulos and explained the location of the store. He reminded Mr. Psilopoulos that he should not serve minors or intoxicated individuals. Mr. Psilopoulos assured the Board that he would know the laws and provide training for his employees. Chairperson Masayko explained the Code requirement that he must allow the Sheriff's Officers access to his establishment at all reasonable hours when pursuing their duties. Mr. Psilopoulos agreed to do so. Member Schutte noted that the Sheriff's Investigative Report indicated support for his license. Member Williamson welcomed him to the community. Mr. Psilopoulos indicated that his residence is at South Lake Tahoe and that he would supervise the operation. Member Williamson wished him success. Member Aldean moved to approve a full packaged liquor license for Greg Psilopoulos, DBA Aloha Discount Liquor, located at 4555 South Carson Street; fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$200 quarterly fee. Motion carried 6-0. Discussion indicated that he hoped to open by October 1 or Nevada Day.

There being no other matters for consideration Chairperson Masayko adjourned the Liquor and Entertainment Board.
